# Sample-path large deviations for a class of heavy-tailed Markov-additive processes*

#### Abstract

For a class of additive processes driven by the affine recursion $X_{n+1}=A_{n+1} X_{n}+B_{n+1}$, we develop a sample-path large deviations principle in the $M_{1}^{\prime}$ topology on $\mathbb{D}[0,1]$. We allow $B_{n}$ to have both signs and focus on the case where Kesten's condition holds on $A_{1}$, leading to heavy-tailed distributions. The most likely paths in our large deviations results are step functions with both positive and negative jumps.

## 1 Introduction

Let $\left\{X_{n}, n \geq 0\right\}$ be an affine recursion such that

$$
\begin{equation*}
X_{n+1}=A_{n+1} X_{n}+B_{n+1} \tag{1.1}
\end{equation*}
$$

for a sequence of i.i.d. $\mathbb{R}^{2}$-valued random vectors $\left(A_{n}, B_{n}\right)$. The Markov chain driven by (1.1) has been studied extensively in the past several decades and continues to pose new research challenges. A classical result, which can be found in [21] and [25] shows that under certain assumptions (see Assumption 2.1 below), the Markov chain $X_{n}, n \geq 0$ has a unique stationary distribution $\pi$, for which we have

\pi(x, \infty) \sim c_{+} x^{-\alpha} \quad \text { and } \quad \pi(-\infty,-x) \sim c_{-} x^{-\alpha}, \quad \text { as } x \rightarrow \infty \tag{1.2}
\end{equation*}
$$

for some $c_{-}, c_{+}$satisfying $c_{-}+c_{+}>0$; see the monograph [8] for a recent comprehensive account

[^0]Define $\bar{X}_{n}=\left\{\bar{X}_{n}(t), t \in[0,1]\right\}$, with

$$
\begin{equation*}
\bar{X}_{n}(t)=\frac{1}{n} \sum_{i=0}^{\lfloor n t\rfloor-1} X_{i}, \quad t \in[0,1] \tag{1.3}
\end{equation*}
$$

The focus of the present paper is on sample-path large deviations of the additive process $\bar{X}_{n}$, assuming the invariant distribution of $X_{n}$ has a heavy tail as in (1.2). The study of additive processes of the form (1.3) is less well developed. Classical theory initiated by Donsker and Varadhan (see, for example, [16, 17]) provides powerful tools designed to study large deviations for additive functionals of light-tailed and geometrically ergodic Markov chains. More recent contributions in this area include [26, 27]. Analogs of these sample-path results in a heavy-tailed setting do not seem to be available.

A considerable body of theory has been developed to analyse exceedance probabilities for random walks with heavy-tailed step sizes. Let such a random walk be given by $\left\{\hat{S}_{n}, n \geq 0\right\}$. Early papers [33,34] identified appropriate sequences $\left(x_{n}\right)$ for which

$$
\begin{equation*}
\mathbf{P}\left(\hat{S}_{n} / n>x_{n}\right)=n \mathbf{P}\left(\hat{S}_{1}>x_{n}\right)(1+o(1)), \quad \text { as } n \rightarrow \infty \tag{1.4}
\end{equation*}
$$

holds, depending on the tail behavior of the distribution of $\hat{S}_{1}$. For a detailed description, we refer to e.g. [6], [15], and [19]. When (1.4) is valid, the so-called principle of a single big jump is said to hold. As a generalization of (1.4), a functional form has been derived in [24], where random walks with i.i.d. multi-dimensional regularly varying (cf. Definition 1.1 of [24]) step sizes are considered.

Several works have focused on the extension of (1.4) to more general processes where there is a certain dependence structure in the increments. Some key references are [20, 23, 30], where stable processes, modulated processes, and stochastic differential equations are considered. Extensions to additive processes of the form considered in this paper have been provided in [31, 32], which also consider more general examples of driving recursion $X_{n+1}=f_{n+1}\left(X_{n}\right)$. The principle of a single big jump is still valid, but an additional constant in the RHS of (1.4) can appear.

Extending the results of $[31,32]$ to the sample-path level poses several phenomenological and technical challenges. So far, all results cited center around the phenomenon where rare events are caused by a single big jump. However, not all rare events are caused by this relatively simple scenario, for early examples see [18, 38]. In a recent paper, [35] provides sample-path large deviations results for Lévy processes and random walks with regularly varying increments, which deal with a general class of rare events that can especially be caused by multiple jumps. For further examples see [10]. However, the case studied here is considerably harder, as big jumps occur by a condensation phenomenon, through the concatenation of many small jumps. In particular, a large value of the sample mean is not due to a single large value of the $A_{n}$ or $B_{n}$ but to large values of the products $A_{1} \cdots A_{n}$, see also [7, 12]. When studying sample-path large deviations, this phenomenon poses nontrivial technical requirements. In particular, an appropriate topology needs to be considered.

Our approach to overcome these challenges is as follows. We first proceed to identify a sequence of regeneration times $r_{n}, n \geq 1$ (see [2]) and split the Markov chain into i.i.d. cycles. By aggregating the trajectory of $\bar{X}_{n}$ over regeneration cycles, we obtain a regenerative process with i.i.d. jump distributions and $r_{n}, n \geq 1$ as renewals. Under a set of assumptions originating from [21] and [25], we establish our first result, Theorem 3.1, which is that the "area" under a typical regeneration cycle, denoted by $\mathfrak{R}$ (see (3.2) below), has an asymptotic power law. To be precise, we have

$$
\begin{equation*}
\mathbf{P}(\Re>x) \sim C_{+} x^{-\alpha} \quad \text { and } \quad \mathbf{P}(\Re<-x) \sim C_{-} x^{-\alpha}, \quad \text { as } x \rightarrow \infty, \tag{1.5}
\end{equation*}
$$

for some constants $C_{-}, C_{+}$. This is related to a result of [12] for the case where $X_{n} \geq 0$. Our argument is different, developed in a two-sided setting, and can be extended to more general recursions, cf. [9].

Using the tail estimates (1.5), we present in Sections 3.2 and 3.3 large deviations results for $\bar{X}_{n}$ as in (1.3), which constitutes the second major step in our approach. We achieve this by introducing a new asymptotic equivalence concept (see Lemma 2.13 below), which, together with the decomposition in cycles, allows us to build a bridge between our problem and the one studied [35]. In the latter paper, the Skorokhod $J_{1}$ topology is used. However, showing that the residual process (i.e. the contribution of the cycle going on at the endpoint of our interval) is negligible in its contribution to $\mathbf{P}\left(\bar{X}_{n} \in E\right)$ is not straightforward, especially when the increments of $\bar{X}_{n}$ are dependent as in the current setting. To overcome this, we switch to a slightly weaker topology, namely the $M_{1}^{\prime}$-topology on $\mathbb{D}[0,1]$ (as defined in [4], see also Section 3.2 below), and derive asymptotic estimates of events involved with the "area" under the last ongoing cycle. This choice of topology is crucial as it allows many light-tailed jumps, occurring within a cycle, to merge into a single heavy-tailed jump.

Our main sample-path large deviations results are presented in Section 3. For the case where $B_{n}$ as in (1.1) is nonnegative, our result establishes that

\begin{equation*}
C_{\mathcal{J}^{*}}\left(E^{\circ}\right) \leq \liminf _{n \rightarrow \infty} \frac{\mathbf{P}\left(\bar{X}_{n} \in E\right)}{(n \mathbf{P}(\Re>n))^{\mathcal{J}^{*}}} \leq \limsup _{n \rightarrow \infty} \frac{\mathbf{P}\left(\bar{X}_{n} \in E\right)}{(n \mathbf{P}(\Re>n))^{\mathcal{J}^{*}}} \leq C_{\mathcal{J}^{*}}\left(E^{-}\right) \tag{1.6}
\end{equation*}
$$

Precise details can be found in Section 3.2 below. At this moment, we just mention that $C_{j}$ is a measure on $\mathbb{D}[0,1]$ for each $j$, and $\mathcal{J}^{*}$ denotes the minimum number of jumps that are required for a nondecreasing, piecewise linear function with drift $\mathbf{E} B_{1} /\left(1-\mathbf{E} A_{1}\right)$ to be in the set $E$. In Section 3.3 we develop a two-sided version of this result.

While we restrict to the case of affine recursions in (1.1), the methods developed in this paper can be extended to more general recursions of the form $X_{n+1}=f_{n+1}\left(X_{n}\right)$, in which $f_{n}(z) / z \rightarrow A_{n}$ as $z \rightarrow \infty$; we refer to [9] for details. On the other hand, our methods require the assumption $A_{n} \geq 0$ in (1.1). If this assumption no longer holds, it is possible to have big jumps of opposite sign in the same regeneration cycle, which requires a topology weaker than $M_{1}^{\prime}$. Functional central limit theorems allowing $A_{n}$ to have both signs were recently derived in [3] using the $M_{2}$ topology.

This paper is organized as follows. In Section 2, we introduce some useful tools for future purposes. We present our main results in Section 3. Sections 4-6 are devoted to the proofs.

## 2 Preliminaries

In this section, we recall and establish some preliminary results. All the proofs are deferred to Section 4. We start by introducing a regularity condition.
Assumption 2.1. The random vector $\left(A_{1}, B_{1}\right)$ satisfies

1. $A_{1} \geq 0$ a.s. and the law of $\log A_{1}$ conditioned on $\left\{A_{1}>0\right\}$ is nonarithmetic.
2. There exists an $\alpha \in(1, \infty)$ such that $\mathbf{E} A_{1}^{\alpha}=1, \mathbf{E} A_{1}^{\alpha} \log ^{+} A_{1}<\infty$ (where $\log ^{+} x=$ $\max \{\log x, 0\}$ ), and $\mathbf{E}\left|B_{1}\right|^{\alpha+\epsilon}<\infty$ for some $\epsilon>0$.
3. $\mathbf{P}\left(A_{1} x+B_{1}=x\right)<1$ for every $x \in \mathbb{R}$.

The conditions in Assumption 2.1 imply that $\mathbf{E} \log A_{1}<0$ and $\mathbf{E} \log ^{+}\left|B_{1}\right|<\infty$, and hence (see e.g. Theorem 2.1.3 of [8]), the Markov chain has a unique stationary distribution, denoted by $\pi$. Moreover, [21] and [25] showed there exist constants $c_{+}, c_{-}$
satisfying $c_{+}+c_{-} \in(0, \infty)$ such that

$$
\begin{equation*}
\pi(x, \infty) \sim c_{+} x^{-\alpha} \quad \text { and } \quad \pi(-\infty,-x) \sim c_{-} x^{-\alpha}, \quad \text { as } x \rightarrow \infty \tag{2.1}
\end{equation*}
$$

A natural question is whether $c_{+}>0$ and/or $c_{-}>0$ in our setting. In [22], sufficient conditions for $c_{+}>0$ and/or $c_{-}>0$ are developed using algebraic methods.

### 2.1 Background from Markov chain theory

We review some concepts from Markov chain theory. We begin by introducing two conditions on general Markov chains. A Markov chain on some general state space ( $\mathrm{S}, \mathcal{S}$ ) with transition kernel $P$ satisfies a drift condition ( $\mathcal{D}$ ) if

$$
\begin{equation*}
\int_{\mathbb{S}} h(y) P(x, d y) \leq \kappa_{1} h(x)+\kappa_{2} \mathbb{1}_{\mathcal{C}}(x) \tag{D}
\end{equation*}
$$

for some $\kappa_{1} \in(0,1)$ and $\kappa_{2}>0$, where $h$ takes values in $[1, \infty)$, and $\mathcal{C}$ is a Borel subset of $\mathbb{R}$. Moreover, we say that a $\phi$-irreducible Markov chain on $(\mathbb{S}, \mathcal{S})$ with transition kernel $P$ satisfies the minorization condition $(\mathcal{M})$ if

$$
\begin{equation*}
\theta \mathbb{1}_{\mathcal{C}_{0}}(x) \phi\left(E \cap E_{0}\right) \leq P(x, E), \quad x \in \mathbb{S}, E \in \mathcal{S}, \tag{M}
\end{equation*}
$$

for some set $E_{0} \subseteq \mathbb{S}$, some set $\mathcal{C}_{0}$ with $\phi\left(\mathcal{C}_{0}\right)>0$, some constant $\theta>0$, and some probability measure $\phi$ on $(\mathbb{S}, \mathcal{S})$.
Remark 2.2. If the minorization condition $(\mathcal{M})$ holds, then there exists a sequence of strictly increasing finite random times $r_{n}, n \geq 1$ such that $\left\{X_{n}\right\}_{n \geq 0}$ regenerates at each $r_{n}$ w.r.t. $\phi$, that is, $\mathbf{P}\left(X_{r_{i}} \in E\right)=\phi\left(E \cap E_{0}\right)$ for each $i$. In particular, $X_{n}$ attempts (independently of everything else) to regenerate each time it enters $\mathcal{C}_{0}$, and such attemps are successful w.p. $\theta$.

Recall that we say that the Markov chain $\left\{X_{n}\right\}_{n \geq 0}$ is geometrically ergodic if there exists some number $\rho_{0} \in(0,1)$ such that

$$
\left\|P^{n}(x, \cdot)-P_{0}(\cdot)\right\|_{T V}=o\left(\rho_{0}^{n}\right)
$$

as $n \rightarrow \infty$.
Result 2.3 (Lemma 2.2.3, Proposition 2.2.4, Theorem 2.4.4 of [8]). Let $\left\{X_{n}\right\}_{n \geq 0}$ be such that $X_{n+1}=A_{n+1} X_{n}+B_{n+1}$. Supposing that Assumption 2.1 holds, we have that:

1. For any given $\delta \in(0, \alpha),\left\{X_{n}\right\}_{n \geq 0}$ satisfies the drift condition ( $\mathcal{D}$ ) with $h(x)=1+|x|^{\delta}$ and $\mathcal{C}=[-M, M]$ for some constant $M \geq 0$.
2. $\left\{X_{n}\right\}_{n \geq 0}$ is $\pi$-irreducible.
3. $\left\{X_{n}\right\}_{n \geq 0}$ is geometrically ergodic.

The regeneration scheme described in Remark 2.2 plays an important role in our analysis. Our next assumption guarantees the existence of the regeneration times.
Assumption 2.4. Condition $(\mathcal{M})$ is satisfied with $\mathcal{C}_{0}=[-d, d]$ for some $d>0$ such that $[-d, d] \cap \operatorname{supp}(\pi) \neq \emptyset$.

For the rest of the paper, we use $r_{n}$ to denote the $n^{\text {th }}$ regeneration time w.r.t. this particular $\mathcal{C}_{0}$ and $\phi$ in Assumption 2.4. Moreover, we assume $r_{0}=0$, so that $X_{0} \in \mathcal{C}_{0}$. For completeness we mention some sufficient conditions for Assumption 2.4 to hold in terms of the joint distribution of $\left(A_{1}, B_{1}\right)$, which is a minor extension of Lemma 2.2.3 of [8]. Let $\mathscr{B}_{r}(x)=\left\{x^{\prime}:\left|x-x^{\prime}\right|<r\right\}$ for $x \in \mathbb{R}$ and $r>0$.

Proposition 2.5. Assume that one of the following conditions hold.

1. Let $B_{1} \geq b$ a.s. for some $b>0$. Moreover, there exist intervals $I_{1}=\left(a_{1}, a_{2}\right) \subseteq \mathbb{R}_{+}$, $I_{2}=\left(b_{0}-\delta, b_{0}+\delta\right)$ for some $a_{1}<a_{2}, b_{0}, \delta>0$, a $\sigma$-finite measure $\nu_{0}$ with $b_{0}$ in the support of $\nu_{0}$, and a constant $c_{0}>0$ such that for any Borel sets $D_{1}, D_{2} \subseteq \mathbb{R}$,

$$
\mathbf{P}\left(\left(A_{1}, B_{1}\right) \in\left(D_{1} \times D_{2}\right)\right) \geq c_{0}\left|D_{1} \cap I_{1}\right| \nu_{0}\left(D_{2} \cap I_{2}\right)
$$

where $|\cdot|$ denotes the Lebesgue measure on $\mathbb{R}$.
2. There exist intervals $I_{1}=\left(a_{0}-\delta, a_{0}+\delta\right) \subseteq \mathbb{R}_{+}, I_{2}=\left(b_{1}, b_{2}\right)$ for some $a_{0}, b_{1}<b_{2}$, $\delta>0$, a $\sigma$-finite measure $\nu_{0}$ with $a_{0}$ in the support of $\nu_{0}$, and a constant $c_{0}>0$ such that for any Borel sets $D_{1}, D_{2} \subseteq \mathbb{R}$,

$$
\begin{equation*}
\mathbf{P}\left(\left(A_{1}, B_{1}\right) \in\left(D_{1} \times D_{2}\right)\right) \geq c_{0} \nu_{0}\left(D_{1} \cap I_{1}\right)\left|D_{2} \cap I_{2}\right| . \tag{2.2}
\end{equation*}
$$

Then, for any $x_{0} \in \mathbb{R}$, there exists $\epsilon=\epsilon\left(x_{0}\right), \theta>0$, and an open interval $E_{0}$ such that

$$
\begin{equation*}
\theta\left|E \cap E_{0}\right| \leq P(x, E), \quad x \in \mathscr{B}_{\epsilon}\left(x_{0}\right), E \in \mathcal{B}(\mathbb{R}) \tag{2.3}
\end{equation*}
$$

Our next result implies the geometric decay of $\mathbf{P}\left(r_{1}>k\right)$ as $k \rightarrow \infty$.
Lemma 2.6. Suppose that Assumptions 2.1 and 2.4 hold. Let $\left\{r_{n}\right\}_{n \geq 0}$ be the sequence of regeneration times associated with $\mathcal{C}_{0}$. Let $E_{1}$ be a bounded set. There exists $t>1$ such that

$$
\sup _{x \in E_{1}} \mathbf{E}\left[t^{r_{1}} \mid X_{0}=x\right]<\infty
$$

### 2.2 A useful change of measure

Another helpful tool in our analysis is the so-called $\alpha$-shifted change of measure (see e.g. $[13,14]$ ). Let $\nu$ denote the distribution of $\left(\log A_{n}, B_{n}\right)$ and define the $\alpha$-shifted measure $\nu^{\alpha}$ by

$$
\nu^{\alpha}(E)=\int_{E} e^{\alpha x} d \nu(x, y), \quad E \in \mathfrak{B}\left(\mathbb{R}^{2}\right)
$$

Let $\mathcal{L}\left(\log A_{n}, B_{n}\right)$ denote the law of $\left(\log A_{n}, B_{n}\right)$. For a stopping time $T$, Let $\mathscr{D}_{T}^{\alpha}$ be the dual change of measure such that, under $\mathscr{D}_{T}^{\alpha}$,

$$
\mathcal{L}\left(\log A_{n}, B_{n}\right)= \begin{cases}\nu^{\alpha}, & \text { for } n \leq T  \tag{2.4}\\ \nu, & \text { for } n>T\end{cases}
$$

Let $\mathbf{P}^{\alpha}, \mathbf{P}^{\mathscr{D}_{T}^{\alpha}}, \mathbf{E}^{\alpha}$ and $\mathbf{E}^{\mathscr{D}_{T}^{\alpha}}$ denote expectation and probability w.r.t. the $\alpha$-shifted measure $\nu^{\alpha}$ and the dual change of measure $\mathscr{D}_{T}^{\alpha}$, respectively. Defining

$$
\begin{equation*}
S_{n}=\sum_{i=1}^{n} \log A_{i} \tag{2.5}
\end{equation*}
$$

we have the following result.
Result 2.7 (Lemma 5.3 of [14]). Let $T$ and $\tau$ be stopping times w.r.t. $\left\{X_{n}\right\}_{n \geq 0}$, let $g: \mathbb{R}^{\infty} \rightarrow[0, \infty]$ be a deterministic function, and let $g_{n}$ denote its projection onto the first $n+1$ coordinates, i.e., $g_{n}\left(x_{0}, \ldots, x_{n}\right)=g\left(x_{0}, \ldots, x_{n}, 0,0, \ldots\right)$. Then

$$
\begin{aligned}
\mathbf{E}\left[g_{\tau-1}\left(X_{0}, \ldots, X_{\tau-1}\right)\right]= & \mathbf{E}^{\mathscr{D}_{T}^{\alpha}}\left[g_{\tau-1}\left(X_{0}, \ldots, X_{\tau-1}\right) e^{-\alpha S_{T}} \mathbb{1}_{\{T<\tau\}}\right] \\
& +\mathbf{E}^{\mathscr{D}_{T}^{\alpha}}\left[g_{\tau-1}\left(X_{0}, \ldots, X_{\tau-1}\right) e^{-\alpha S_{\tau}} \mathbb{1}_{\{T \geq \tau\}}\right] .
\end{aligned}
$$

Remark 2.8. Note that by the same argument, if a random variable $R$ is measurable w.r.t. the stopped $\sigma$-algebra $\mathcal{F}_{T}$, then

$$
\mathbf{E}[R]=\mathbf{E}^{\mathscr{D}_{T}^{\alpha}}\left[R e^{-\alpha S_{T}}\right]=\mathbf{E}^{\alpha}\left[R e^{-\alpha S_{T}}\right] .
$$

Our analysis relies on the fact that the Markov chain $X_{n}$ is closely related to a multiplicative random walk, that is,

$$
X_{n+1} \approx A_{n+1} X_{n}, \quad \text { for large } n
$$

Roughly speaking, the process $X_{n}$ resembles a perturbation of a multiplicative random walk, in an asymptotic sense (for details see [13, 14]). Hence, it is natural to consider the "discrepancy" process between $X_{n}$ and $\prod_{i=1}^{n} A_{i}$, which is defined as

$$
\begin{equation*}
Z_{n}=X_{n} e^{-S_{n}}=X_{0}+\sum_{k=1}^{n} B_{k} e^{-S_{k}}, \quad n \geq 0 \tag{2.6}
\end{equation*}
$$

where $S_{n}$ is as in (2.5). Under the $\alpha$-shifted measure, we have $\mathbf{E}^{\alpha} \log A_{1}=\mathbf{E} A_{1}^{\alpha} \log A_{1}>0$ by Assumption 2.1 and Theorem 2.4.4 of [8]. Consequently, we have the following result.
Lemma 2.9. Let Assumption 2.1 hold. Under $\mathbf{P}^{\alpha}$,

1. $\left|X_{n}\right| \uparrow \infty$ a.s. as $n \rightarrow \infty$.
2. $Z_{n} \xrightarrow{\text { a.s. }} Z$ as $n \rightarrow \infty$, where $Z=X_{0}+\sum_{k=1}^{\infty} B_{k} e^{-S_{k}}$.

### 2.3 M-convergence

We briefly review the notion of IM-convergence [28, 35], and introduce a novel asymptotic equivalence concept. Let $(\mathbb{S}, d)$ be a complete separable metric space, and $\mathscr{S}$ be the Borel $\sigma$-algebra on $\mathbb{S}$. Given a closed subset $\mathbb{C}$ of $\mathbb{S}$, let $\mathbb{S} \backslash \mathbb{C}$ be equipped with the relative topology as a subspace of $\mathbb{S}$, and consider the associated sub $\sigma$-algebra $\mathscr{S}_{\mathbb{S} \backslash \mathbb{C}}=\{E: E \subseteq \mathbb{S} \backslash \mathbb{C}, E \in \mathscr{S}\}$ on it. Define $\mathbb{C}^{r}=\{x \in \mathbb{S}: d(x, \mathbb{C})<r\}$ for $r>0$, and let $\mathbb{M}(\mathbb{S} \backslash \mathbb{C})$ be the class of measures defined on $\mathscr{S}_{\mathbb{S} \backslash \mathbb{C}}$ whose restrictions to $\mathbb{S} \backslash \mathbb{C}^{r}$ are finite for all $r>0$. Topologize $\mathbb{M}(\mathbb{S} \backslash \mathbb{C})$ with a sub-basis $\{\{\nu \in \mathbb{M}(\mathbb{S} \backslash \mathbb{C}): \nu(f) \in$ $G\}: f \in \mathcal{C}_{\mathbb{S} \backslash \mathbb{C}}, G$ open in $\left.\mathbb{R}_{+}\right\}$, where $\mathcal{C}_{\mathbb{S} \backslash \mathbb{C}}$ is the set of real-valued, nonnegative, bounded, continuous functions whose support is bounded away from $\mathbb{C}$ (i.e., $f\left(\mathbb{C}^{r}\right)=\{0\}$ for some $r>0)$. A sequence of measures $\nu_{n} \in \mathbb{M}(\mathbb{S} \backslash \mathbb{C})$ converges to $\nu \in \mathbb{M}(\mathbb{S} \backslash \mathbb{C})$ if $\nu_{n}(f) \rightarrow \nu(f)$ for each $f \in \mathcal{C}_{\mathbb{S} \backslash \mathbb{C}}$. We say that a set $E_{1} \subseteq \mathbb{S}$ is bounded away from another set $E_{2} \subseteq \mathbb{S}$ if $\inf _{x \in E_{1}, y \in E_{2}} d(x, y)>0$. The following characterization of IM-convergence can be considered as a generalization of the classical notion of weak convergence of measures, see e.g. [5].
Result 2.10 (Theorem 2.1 of [28]). Let $\nu, \nu_{n} \in \mathbb{M}(\mathbb{S} \backslash \mathbb{C})$. We have $\nu_{n} \rightarrow \nu$ in $\mathbb{M}(\mathbb{S} \backslash \mathbb{C})$ as $n \rightarrow \infty$ if and only if

$$
\limsup _{n \rightarrow \infty} \nu_{n}(F) \leq \nu(F)
$$

for all closed $F \in \mathscr{S}_{\mathbb{S} \backslash \mathbb{C}}$ bounded away from $\mathbb{C}$ and

$$
\liminf _{n \rightarrow \infty} \nu_{n}(G) \geq \nu(G)
$$

for all open $G \in \mathscr{S}_{\mathbb{S} \backslash \mathbb{C}}$ bounded away from $\mathbb{C}$.
We now introduce a new notion of equivalence between two families of random objects, which will prove to be useful in Section 6. Let $F_{\delta}=\{x \in \mathbb{S}: d(x, F) \leq \delta\}$ and $G^{-\delta}=\left(\left(G^{c}\right)_{\delta}\right)^{c}$. Note that when it comes to the fattening and shaving of sets, we denote open sets with a superscript and closed sets with a subscript.

Definition 2.11. Suppose that $X_{n}$ and $Y_{n}$ are random elements taking values in a complete separable metric space $(\mathbb{S}, d)$. $Y_{n}$ is said to be asymptotically equivalent to $X_{n}$ with respect to $\epsilon_{n}$ and $\mathbb{C}$, if, for each $\delta>0$ and $\gamma>0$,

$$
\begin{aligned}
& \limsup _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(X_{n} \in(\mathbb{S} \backslash \mathbb{C})^{-\gamma}, d\left(X_{n}, Y_{n}\right) \geq \delta\right) \\
& =\limsup _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(Y_{n} \in(\mathbb{S} \backslash \mathbb{C})^{-\gamma}, d\left(X_{n}, Y_{n}\right) \geq \delta\right)=0
\end{aligned}
$$

Remark 2.12. Note that the asymptotic equivalence w.r.t. $\mathbb{C}$ implies the asymptotic equivalence w.r.t. $\mathbb{C}^{\prime}$ if $\mathbb{C} \subseteq \mathbb{C}^{\prime}$. In view of this, the strongest notion of asymptotic equivalence w.r.t. a given sequence $\epsilon_{n}$ is the one w.r.t. an empty set. In this case, the conditions for the asymptotic equivalence reduce to a simple condition: $\mathbf{P}\left(d\left(X_{n}, Y_{n}\right) \geq\right.$ $\delta)=o\left(\epsilon_{n}\right)$ for any $\delta>0$. That special case of asymptotic equivalence has been introduced and applied in [35]. In our context, this simple condition suffices for the case of $B_{1} \geq 0$ in Section 3.2; however, we have to work with the case that $\mathbb{C}$ is not an empty set when we deal with general $B_{1}$ in Section 3.3.

The usefulness of this notion of equivalence comes from the following result.
Lemma 2.13. Suppose that $\epsilon_{n}^{-1} \mathbf{P}\left(X_{n} \in \cdot\right) \rightarrow \nu(\cdot)$ in $\mathbb{M}(\mathbb{S} \backslash \mathbb{C})$ for some sequence $\epsilon_{n}$ and a closed set $\mathbb{C}$. If $Y_{n}$ is asymptotically equivalent to $X_{n}$ with respect to $\epsilon_{n}$ and $\mathbb{C}$, then the law of $Y_{n}$ has the same normalized limit, i.e., $\epsilon_{n}^{-1} \mathbf{P}\left(Y_{n} \in \cdot\right) \rightarrow \nu(\cdot)$ in $\operatorname{MM}(\mathbb{S} \backslash \mathbb{C})$.

## 3 Main results

This section is organized as follows. In Section 3.1, we analyze the tail estimates of the area under the first return time and regeneration cycle, which are needed to derive the sample-path large deviations of $\bar{X}_{n}$. In Section 3.2 we derive such results in the case where $B_{1} \geq 0$. The two-sided case is more involved and is treated in Section 3.3.

### 3.1 Tail estimates on the area under the first return time/regeneration cycle

Let

$$
\begin{equation*}
\tau_{d}=\inf \left\{n \geq 1:\left|X_{n}\right| \leq d\right\} \tag{3.1}
\end{equation*}
$$

denote the first return time of $X_{n}$ to the set $[-d, d]$, where $d$ is such that $[-d, d] \cap \operatorname{supp}(\pi) \neq$ $\emptyset$. Recall that $\left\{r_{n}\right\}_{n \geq 0}$ is the sequence of regeneration times of $\left\{X_{n}\right\}_{n \geq 0}$. We denote the area under the first return time and the regeneration cycle by

$$
\begin{equation*}
\mathfrak{B}=\sum_{n=0}^{\tau_{d}-1} X_{n} \quad \text { and } \quad \mathfrak{R}=\sum_{n=0}^{r_{1}-1} X_{n} \tag{3.2}
\end{equation*}
$$

respectively. Recall that $Z=X_{0}+\sum_{k=1}^{\infty} B_{k} e^{-S_{k}}$. Finally, note that considering $B_{i} \equiv 1$, there exists a constant $C_{\infty}$ given in [21] that satisfies

$$
\begin{equation*}
\mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>u\right) \sim C_{\infty} u^{-\alpha} \tag{3.3}
\end{equation*}
$$

Theorem 3.1. Suppose that Assumptions 2.1 and 2.4 hold.

1. We have

$$
\begin{array}{ll} 
& \lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}(\mathfrak{B}>u)=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right] \\
\text { and } & \lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}(\mathfrak{B}<-u)=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{-}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right] .
\end{array}
$$

2. In addition

$$
\lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}(\Re>u)=C_{+} \quad \text { and } \quad \lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}(\Re<-u)=C_{-},
$$

$$
\text { where } C_{+}=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{r_{1}=\infty\right\}}\right] \text { and } C_{-}=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{-}\right)^{\alpha} \mathbb{1}_{\left\{r_{1}=\infty\right\}}\right]
$$

Like in the classical estimates (2.1), it is natural to ask when $C_{+}, C_{-} \in(0, \infty)$. A proof of finiteness of $\mathbf{E}^{\alpha}\left[|Z|^{\alpha}\right]$ is obtained as byproduct of the proof of Lemma 5.6. $C_{\infty} \in(0, \infty)$ by specializing (2.1) to the case $A_{1} \geq 0$ and $B_{1} \equiv 1$. If $B_{1}$ is nonnegative and $\mathbf{P}\left(A_{1}=B_{1}=0\right)=0$, then $Z>0 \mathbf{P}^{\alpha}$-a.s. Since also $\mathbf{P}^{\alpha}\left(r_{1}=\infty\right)>0, C_{+}>0$.

When $B_{1}$ can take both signs, the situation is much more delicate and we sketch how one can deal with this issue. One way is to derive sufficient conditions for the support of $Z$ under $\mathbf{P}^{\alpha}$ to be the entire real line, from which strict positivity of both $C_{+}$and $C_{-}$ can be inferred. Such a sufficient condition can be derived from a careful inspection of the proof of Theorem 2.5.5 (1) of [8] (which is a result due to [22]). For example, if the support of $\left(A_{1}, B_{1}\right)$ includes points $(a, b),\left(a_{1}, b_{1}\right),\left(a_{2}, b_{2}\right)$ such that $a<1, a_{1}, a_{2}>1$ and $b_{1} /\left(1-a_{1}\right)<b /(1-a)<b_{2} /\left(1-a_{2}\right)$ the support of $Z$ is the whole real line.

### 3.2 One-sided large deviations

We first consider the case where $B_{1}$ is nonnegative. To deal with the dependence structure of the Markov chain within the regeneration cycle, we consider in this section the space $\mathbb{D}=\mathbb{D}[0,1]$, consisting of real-valued functions with domain $[0,1]$ which are right-continuous with left limits. We endow $\mathbb{D}$ with the $M_{1}^{\prime}$ topology. To describe this topology in detail, let $\xi \in \mathbb{D}$ and define the extended completed graph $\Gamma_{\xi}^{\prime}$ of $\xi$ by

$$
\Gamma_{\xi}^{\prime}=\left\{(x, t) \in \mathbb{R} \times[0,1]: x \in\left[\xi\left(t^{-}\right) \wedge \xi(t), \xi\left(t^{-}\right) \vee \xi(t)\right]\right\}
$$

where $\xi\left(0^{-}\right)=0$. Define an order on the graph $\Gamma_{\xi}^{\prime}$ by saying that $\left(x_{1}, t_{1}\right) \leq\left(x_{2}, t_{2}\right)$ if either (i) $t_{1}<t_{2}$ or (ii) $t_{1}=t_{2}$ and $\left|\xi\left(t_{1}^{-}\right)-x_{1}\right| \leq\left|\xi\left(t_{2}^{-}\right)-x_{2}\right|$. We say that a mapping $(u, s):[0,1] \rightarrow \Gamma_{\xi}^{\prime}$ is a parametric representation of $\xi$ if $r \mapsto(u(r), s(r))$ is continuous and nondecreasing. Let $\Pi^{\prime}(\xi)$ be the set of all parametric representations of $\xi \in \mathbb{D}$. For any $\xi_{1}, \xi_{2} \in \mathbb{D}$, the $M_{1}^{\prime}$ metric is defined by

$$
d_{M_{1}^{\prime}}\left(\xi_{1}, \xi_{2}\right)=\inf _{\substack{\left(u_{i}, s_{i}\right) \in \Pi^{\prime}\left(\xi_{i}\right) \\ i \in\{1,2\}}}\left\|u_{1}-u_{2}\right\|_{\infty} \vee\left\|s_{1}-s_{2}\right\|_{\infty} .
$$

For the rest of the paper, we consider the topology w.r.t. this metric, unless specified otherwise.

For the one-sided large deviations result, we need the following elements. We say that a function $\xi \in \mathbb{D}$ is piecewise constant, if there exist finitely many time points $t_{i}$ such that $0=t_{0}<t_{1}<\cdots<t_{m}=1$ and $\xi$ is constant on the intervals $\left[t_{i-1}, t_{i}\right)$ for all $1 \leq i \leq m$. For $\xi \in \mathbb{D}$, define the set of discontinuities of $\xi$ by

$$
\begin{equation*}
\operatorname{Disc}(\xi)=\left\{t \in[0,1]: \xi(t) \neq \xi\left(t^{-}\right)\right\}, \tag{3.4}
\end{equation*}
$$

where $\xi\left(0^{-}\right)=0$. For each integer $j$, define

$$
\underline{\mathbb{D}}_{<j}=\{\xi \in \mathbb{D}: \xi \text { piecewise constant and nondecreasing, }|\operatorname{Disc}(\xi)|<j\} .
$$

For $z \in \mathbb{R}$ and each integer $j$, define

$$
\begin{equation*}
\underline{\mathbb{D}}_{<j}^{z}=\left\{\xi \in \mathbb{D}: \xi=z \cdot i d+\xi^{\prime}, \xi^{\prime} \in \underline{\mathbb{D}}_{<j}\right\} . \tag{3.5}
\end{equation*}
$$

For each constant $\gamma>1$, let $\nu_{\gamma}(x, \infty)=x^{-\gamma}$, and let $\nu_{\gamma}^{j}$ denote the restriction (to $\mathbb{R}_{+}^{j \downarrow}=\left\{x \in \mathbb{R}^{j}: x_{1} \geq \cdots \geq x_{j}>0\right\}$ ) of the $j$-fold product measure of $\nu_{\gamma}$. Let $C_{0}^{z}$ be the

Dirac measure concentrated on the linear function $z t$. For $j \geq 1$, define a sequence of Borel measures $C_{j}^{z} \in \mathbb{M}\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{<j}\right)$ concentrated on $\underline{\mathbb{D}}_{<j+1}$ as

$$
\begin{equation*}
C_{j}^{z}(\cdot)=\mathbf{E}\left[\nu_{\alpha}^{j}\left\{x \in(0, \infty)^{j}: z \cdot i d+\sum_{i=1}^{j} x_{i} \mathbb{1}_{U_{i}} \in \cdot\right\}\right] \tag{3.6}
\end{equation*}
$$

where $\alpha$ is as in Assumption 2.1 and the random variables $U_{i}, i \geq 1$, are independent and uniform distributed on $[0,1]$. For $E \subseteq \mathbb{D}$ and $z \in \mathbb{R}$, define

$$
\begin{equation*}
\mathcal{J}_{z}^{\uparrow}(E)=\inf \left\{j: E \cap \underline{\mathbb{D}}_{<j+1}^{z} \neq \emptyset\right\} \tag{3.7}
\end{equation*}
$$

Setting $\mu=\int x \pi(d x)=\mathbf{E} B_{1} /\left(1-\mathbf{E} A_{1}\right)$, we state below the main theorem for the one-sided case. Recall $C_{+}$defined in Theorem 3.1. As kindly pointed out by a referee, if $B_{1} \geq 0$ a.s., then thanks to Assumption 2.1 $\mathbf{P}\left(B_{1}=0\right)<1$ and $C_{+}$must be strictly positive, due to (2.12) in [21].
Theorem 3.2. Suppose that Assumptions 2.1 and 2.4 hold. Moreover, let $B_{1} \geq 0$.

1. For each $j \geq 1$,

$$
n^{j(\alpha-1)} \mathbf{P}\left(\bar{X}_{n} \in \cdot\right) \rightarrow\left(C_{+} \mathbf{E} r_{1}\right)^{j} C_{j}^{\mu}(\cdot),
$$

in $\operatorname{MM}\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{<j}^{\mu}\right)$ as $n \rightarrow \infty$.
2. Let $E$ be measurable. If $\mathcal{J}_{\mu}^{\uparrow}(E)<\infty$ and $E$ is bounded away from $\underline{\mathrm{D}}_{<\mathcal{J}_{\mu}^{\uparrow}(E)}$, then

$$
\begin{aligned}
& \liminf _{n \rightarrow \infty} \frac{\mathbf{P}\left(\bar{X}_{n} \in E\right)}{n^{-\mathcal{J}_{\mu}^{\uparrow}(E)(\alpha-1)}} \geq\left(C_{+} \mathbf{E} r_{1}\right)^{\mathcal{J}_{\mu}^{\uparrow}(E)} C_{\mathcal{J}_{\mu}^{\uparrow}(E)}^{\mu}\left(E^{\circ}\right) \\
& \limsup _{n \rightarrow \infty} \\
& \frac{\mathbf{P}\left(\bar{X}_{n} \in E\right)}{n^{-\mathcal{J}_{\mu}^{\uparrow}(E)(\alpha-1)}} \leq\left(C_{+} \mathbf{E} r_{1}\right)^{\mathcal{J}_{\mu}^{\uparrow}(E)} C_{\mathcal{J}_{\mu}^{\uparrow}(E)}^{\mu}\left(E^{-}\right) .
\end{aligned}
$$

### 3.3 Two-sided large deviations

Similarly as in Section 3.2, we need the following elements. Define the set of step functions with less than $j$ discontinuities by

$$
\underline{\mathbb{D}}_{\ll j}=\{\xi \in \mathbb{D}: \xi \text { piecewise constant, }|\operatorname{Disc}(\xi)|<j\}, \quad \text { for } j \geq 0
$$

For $z \in \mathbb{R}$, define

$$
\begin{equation*}
\underline{\mathbb{D}}_{\ll j}^{z}=\left\{\xi \in \mathbb{D}: \xi=z \cdot i d+\xi^{\prime}, \xi^{\prime} \in \underline{D}_{\ll j}\right\}, \quad \text { for } j \geq 0 \tag{3.8}
\end{equation*}
$$

Let $C_{0,0}^{z}$ be the Dirac measure concentrated on the linear function $z t$. For each $(j, k) \in$ $\mathbb{Z}_{+}^{2} \backslash\{(0,0)\}$, define a measure $C_{j, k}^{z}$ as

$$
\begin{equation*}
C_{j, k}^{z}(\cdot)=\mathbf{E}\left[\nu_{\alpha}^{j+k}\left\{(x, y) \in(0, \infty)^{j+k}: z \cdot i d+\sum_{i=1}^{j} x_{i} \mathbb{1}_{U_{i}}-\sum_{i=1}^{k} y_{i} \mathbb{1}_{V_{i}} \in \cdot\right\}\right] \tag{3.9}
\end{equation*}
$$

where $U_{i}, V_{i}$ are independent and uniform distributed on $[0,1]$. For $E \subseteq \mathbb{D}$ and $z \in \mathbb{R}$, define

$$
\begin{equation*}
\mathcal{J}_{z}(E)=\inf \left\{j: E \cap \underline{\mathbb{D}}_{\ll j+1}^{z} \neq \emptyset\right\} \tag{3.10}
\end{equation*}
$$

Recalling $\mu=\mathbf{E} B_{1} /\left(1-\mathbf{E} A_{1}\right)$, we now state our main theorem for the two-sided case.
Theorem 3.3. Suppose that Assumptions 2.1 and 2.4 hold. Let $\mathbf{E}\left|B_{1}\right|^{m}<\infty$ for every $m \in \mathbb{Z}_{+}$. Moreover, let $C_{+}, C_{-}$be as in Theorem 3.1 such that $C_{+} C_{-}>0$.

1. For each $j \geq 1$,

$$
n^{j(\alpha-1)} \mathbf{P}\left(\bar{X}_{n} \in \cdot\right) \rightarrow\left(\mathbf{E} r_{1}\right)^{j} \sum_{(l, m) \in I_{=j}}\left(C_{+}\right)^{l}\left(C_{-}\right)^{m} C_{l, m}^{\mu}(\cdot)
$$

in $\operatorname{M}\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)$ as $n \rightarrow \infty$, where $I_{=j}=\left\{(l, m) \in \mathbb{Z}_{+}^{2}: l+m=j\right\}$.
2. Let $E$ be measurable. If $\mathcal{J}_{\mu}(E)<\infty$ and $E$ is bounded away from $\underline{\mathbb{D}}_{\ll \mathcal{J}_{\mu}(E)}$, then

$$
\begin{aligned}
& \liminf _{n \rightarrow \infty} \frac{\mathbf{P}\left(\bar{X}_{n} \in E\right)}{n^{-\mathcal{J}_{\mu}(E)(\alpha-1)}} \geq\left(\mathbf{E} r_{1}\right)^{\mathcal{J}_{\mu}(E)} \sum_{(l, m) \in I_{=\mathcal{J}_{\mu}(E)}}\left(C_{+}\right)^{l}\left(C_{-}\right)^{m} C_{l, m}^{\mu}\left(E^{\circ}\right) \\
& \limsup _{n \rightarrow \infty} \frac{\mathbf{P}\left(\bar{X}_{n} \in E\right)}{n^{-\mathcal{J}_{\mu}(E)(\alpha-1)}} \leq\left(\mathbf{E} r_{1}\right)^{\mathcal{J}_{\mu}(E)} \sum_{(l, m) \in I_{=\mathcal{J}_{\mu}(E)}}\left(C_{+}\right)^{l}\left(C_{-}\right)^{m} C_{l, m}^{\mu}\left(E^{-}\right),
\end{aligned}
$$

where the summations are over all $(l, m)$ that belong to the set $I_{=\mathcal{J}_{\mu}(E)}$.

## 4 Proofs of Section 2

Proof of Proposition 2.5. Part 1) and Part 2) for the case $x_{0} \neq 0$ are in [8, page 22]. Hence, we focus on showing part 2) for the case $x_{0}=0$.

Note that for any Borel set $E$, (2.2) implies that

P(x, E) & =\mathbf{E}\left[\mathbb{1}_{\left\{A_{1} x+B_{1} \in E\right\}}\right] \geq c_{0} \int_{a_{0}-\epsilon}^{a_{0}+\epsilon} \int_{I_{2}} \mathbb{1}_{\{a x+b \in E\}} d b \nu_{0}(d a) \\
& =c_{0} \int_{a_{0}-\epsilon}^{a_{0}+\epsilon} \int \mathbb{1}_{\left\{z-a x \in I_{2}\right\}} \mathbb{1}_{\{z \in E\}} d z \nu_{0}(d a) .
\end{aligned}
$$

Let

$$
E_{0}= \begin{cases}\left(b_{1}+\epsilon\left(a_{0}+\epsilon\right), b_{2}-\epsilon\left(a_{0}+\epsilon\right)\right) & \text { if } x_{0}=0 \\ \left(b_{1}+\left(x_{0}+\epsilon\right)\left(a_{0}+\epsilon\right), b_{2}+\left(x_{0}-\epsilon\right)\left(a_{0}-\epsilon\right)\right) & \text { if } x_{0}>0 \\ \left(b_{1}+\left(x_{0}+\epsilon\right)\left(a_{0}-\epsilon\right), b_{2}+\left(x_{0}-\epsilon\right)\left(a_{0}+\epsilon\right)\right) & \text { if } x_{0}<0\end{cases}
$$

and pick an $\epsilon>0$ sufficiently small so that $E_{0}$ is nonempty and $\epsilon<\left|x_{0}\right| \wedge a_{0}$. Note that if $x \in \mathscr{B}_{\epsilon}\left(x_{0}\right), z \in E_{0}$, and $a \in\left(a_{0}-\epsilon, a_{0}+\epsilon\right)$, then $z \in E_{0}$ implies $z-a x \in I_{2}$; that is, $\mathbb{1}_{\left\{z \in E_{0}\right\}} \leq \mathbb{1}_{\left\{z-a x \in I_{2}\right\}}$. Therefore, we have that for all $x \in \mathscr{B}_{\epsilon}\left(x_{0}\right)$,

P(x, E) \geq c_{0} \int_{a_{0}-\epsilon}^{a_{0}+\epsilon} \int \mathbb{1}_{\left\{z \in E_{0}\right\}} \mathbb{1}_{\{z \in E\}} d z \nu_{0}(d a) \geq c_{0} \nu_{0}\left(\left(a_{0}-\epsilon, a_{0}+\epsilon\right)\right)\left|E \cap E_{0}\right|
$$

The constant $\theta=c_{0} \nu_{0}\left(\left(a_{0}-\epsilon, a_{0}+\epsilon\right)\right)$ is strictly positive since $a_{0}$ belongs to the support of $\nu_{0}$.

Proof of Lemma 2.6. By Theorem 15.2.6 of [29] and Result 2.3, any bounded set is $h$-geometrically regular with $h(x)=|x|^{\delta}+1, \delta \in(0, \alpha)$. Thus, from the definition of $h$-geometrical regularity (cf. page 373 of [29]), there exists $t>1$ such that
$\sup _{x \in E_{1}} \mathbf{E}\left[\sum_{k=0}^{\tau_{d}-1} h\left(X_{k}\right) t^{k} \mid X_{0}=x\right]<\infty$ and $\sup _{x \in \mathcal{C}_{0}} \mathbf{E}\left[\sum_{k=0}^{\tau_{d}-1} h\left(X_{k}\right) t^{k} \mid X_{0}=x\right]<\infty$. Since $h \geq 1$,

$$
\begin{equation*}
\chi_{0}(t) \triangleq \sup _{x \in E_{1}} \mathbf{E}\left[t^{\tau_{d}} \mid X_{0}=x\right]<\sup _{x \in E_{1}} \mathbf{E}\left[\sum_{k=0}^{\tau_{d}-1} h\left(X_{k}\right) t^{k} \mid X_{0}=x\right]<\infty \tag{4.1}
\end{equation*}
$$

Likewise, $\chi_{1}(t) \triangleq \sup _{x \in \mathcal{C}_{0}} \mathbf{E}\left[t^{\tau_{d}} \mid X_{0}=x\right]<\infty$. Note that for any $s \in(1, t)$, by Jensen's inequality, we get

$$
\chi_{1}(s)=\sup _{x \in \mathcal{C}_{0}} \mathbf{E}\left[s^{\tau_{d}} \mid X_{0}=x\right]=\sup _{x \in \mathcal{C}_{0}} \mathbf{E}\left[\left.t^{\frac{\log s}{\log t} \tau_{d}} \right\rvert\, X_{0}=x\right]
$$

Large deviations for heavy-tailed Markov-additive processes

$$
\leq \sup _{x \in \mathcal{C}_{0}} \mathbf{E}\left[t^{\tau_{d}} \mid X_{0}=x\right]^{\frac{\log s}{\log t}}=\chi_{1}(t)^{\frac{\log s}{\log t}} \rightarrow 1
$$

as $s \rightarrow 1$. Now let $t>1$ be sufficiently close to 1 so that $(1-\theta) \chi_{1}(t)<1$. From the regeneration scheme as described in Remark 2.2, we obtain

$$
\begin{equation*}
\sup _{x \in E_{1}} \mathbf{E}\left[t^{r_{1}} \mid X_{0}=x\right] \leq \chi_{0}(t)\left(\theta+\sum_{n=1}^{\infty} \theta(1-\theta)^{n}\left(\chi_{1}(t)\right)^{n}\right)<\infty . \tag{4.2}
\end{equation*}
$$

Proof of Lemma 2.9. The second statement follows from Theorem 2.1.3 of [8] since the random walk $-S_{n}$ has a negative drift under $\mathbf{P}^{\alpha}$ and $\mathbf{E}^{\alpha}\left[\log B_{1}\right]<\infty$. To prove the first statement, we begin by using a similar argument, invoking Assumption 2.1, to conclude that the random variable $\sum_{i=1}^{\infty}\left|B_{i}\right| e^{-S_{i}}$ is a.s. finite. Consequently, we can lower bound

$$
\left|X_{n}\right|=e^{S_{n}}\left|X_{0}+\sum_{i=1}^{n} B_{i} e^{-S_{i}}\right| \geq e^{S_{n}}\left(\left|X_{0}\right|-\sum_{i=1}^{n}\left|B_{i}\right| e^{-S_{i}}\right) \geq e^{S_{n}}\left(\left|X_{0}\right|-\sum_{i=1}^{\infty}\left|B_{i}\right| e^{-S_{i}}\right) .
$$

and we see that $\left|X_{n}\right| \rightarrow \infty$ on the event $\left\{\sum_{i=1}^{\infty}\left|B_{i}\right| e^{-S_{i}}<M ; X_{0}>2 M\right\}$ since $S_{n} \rightarrow \infty$ under $\mathbf{P}^{\alpha}$. Hence, we can conclude that

$$
\mathbf{P}^{\alpha}\left(\left|X_{n}\right| \geq M, \text { for all } n \geq 1| | X_{0} \mid \geq 2 M\right)>0
$$

Combining this with the fact that the set $[M, \infty)$ is attainable by $\left\{\left|X_{n}\right|\right\}_{n \geq 0}$ for sufficiently large $M$ (by Assumption 2.1), Theorem 8.3.6 of [29] completes the proof.

Proof of Lemma 2.13. Let $G$ be an open set bounded away from $\mathbb{C}$ so that $G \subseteq(\mathbb{S} \backslash \mathbb{C})^{-\gamma}$ for some $\gamma>0$. For a given $\delta>0$, due to the assumed asymptotic equivalence, $\mathbf{P}\left(X_{n} \in(S \backslash \mathbb{C})^{-\gamma}, d\left(X_{n}, Y_{n}\right) \geq \delta\right)=o\left(\epsilon_{n}\right)$. Therefore,

$$
\begin{aligned}
\liminf _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(Y_{n} \in G\right) & \geq \liminf _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(X_{n} \in G^{-\delta}, d\left(X_{n}, Y_{n}\right)<\delta\right) \\
& =\liminf _{n \rightarrow \infty} \epsilon_{n}^{-1}\left\{\mathbf{P}\left(X_{n} \in G^{-\delta}\right)-\mathbf{P}\left(X_{n} \in G^{-\delta}, d\left(X_{n}, Y_{n}\right) \geq \delta\right)\right\} \\
& \geq \liminf _{n \rightarrow \infty}^{-1}\left\{\mathbf{P}\left(X_{n} \in G^{-\delta}\right)-\mathbf{P}\left(X_{n} \in(\mathbb{S} \backslash \mathbb{C})^{-\gamma}, d\left(X_{n}, Y_{n}\right) \geq \delta\right)\right\} \\
& =\liminf _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(X_{n} \in G^{-\delta}\right) \geq \nu\left(G^{-\delta}\right)
\end{aligned}
$$

Since $G$ is an open set, $G=\bigcup_{\delta>0} G^{-\delta}$. Due to the continuity of measures, $\lim _{\delta \rightarrow 0} \nu\left(G^{-\delta}\right)=$ $\nu(G)$, and hence, we arrive at the lower bound

$$
\liminf _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(Y_{n} \in G\right) \geq \nu(G)
$$

by taking $\delta \rightarrow 0$. Now, turning to the upper bound, consider a closed set $F$ bounded away from $\mathbb{C}$ so that $F \subseteq(\mathbb{S} \backslash \mathbb{C})^{-\gamma}$ for some $\gamma>0$. Given a $\delta>0$, by the asymptotic equivalence assumption, $\mathbf{P}\left(Y_{n} \in F, d\left(X_{n}, Y_{n}\right) \geq \delta\right) \leq \mathbf{P}\left(Y_{n} \in(\mathbb{S} \backslash \mathbb{C})^{-\gamma}, d\left(X_{n}, Y_{n}\right) \geq \delta\right)=o\left(\epsilon_{n}\right)$. Therefore,

$$
\begin{aligned}
\limsup _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(Y_{n} \in F\right) & =\limsup _{n \rightarrow \infty} \epsilon_{n}^{-1}\left\{\mathbf{P}\left(Y_{n} \in F, d\left(X_{n}, Y_{n}\right)<\delta\right)+\mathbf{P}\left(Y_{n} \in F, d\left(X_{n}, Y_{n}\right) \geq \delta\right)\right\} \\
& \leq \limsup _{n \rightarrow \infty} \epsilon_{n}^{-1}\left\{\mathbf{P}\left(X_{n} \in F_{\delta}\right)+\mathbf{P}\left(Y_{n} \in F, d\left(X_{n}, Y_{n}\right) \geq \delta\right)\right\} \\
& =\limsup _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(X_{n} \in F_{\delta}\right) \leq \nu\left(F_{\delta}\right)
\end{aligned}
$$

as long as $\delta$ is small enough so that $F_{\delta}$ is bounded away from $\mathbb{C}$. Note that $\left\{F_{\delta}\right\}$ is a decreasing sequence of sets, $F=\bigcap_{\delta>0} F_{\delta}$ (since $F$ is closed), and $\nu \in \operatorname{M}(\mathbb{S} \backslash \mathbb{C}$ ) (and hence $\nu$ is a finite measure on $\mathbb{S} \backslash \mathbb{C}^{r}$ for some $r>0$ such that $F_{\delta} \subseteq \mathbb{S} \backslash \mathbb{C}^{r}$ for some $\delta>0$ ). Due to the continuity (from above) of finite measures, $\lim _{\delta \rightarrow 0} \nu\left(F_{\delta}\right)=\nu(F)$. Therefore, we arrive at the upper bound $\lim \sup _{n \rightarrow \infty} \epsilon_{n}^{-1} \mathbf{P}\left(Y_{n} \in F\right) \leq \nu(F)$ by taking $\delta \rightarrow 0$.

## 5 Proofs of Section 3.1

This section provides the proof of Theorem 3.1. Before turning to technical details, we briefly describe our strategy for proving the tail asymptotics of $\mathfrak{B}$. A similar idea is behind the proof for $\mathfrak{R}$. Let

$$
\begin{equation*}
T(u)=\inf \left\{n \geq 0:\left|X_{n}\right|>u\right\} \quad \text { and } \quad K_{\beta}^{\gamma}(u)=\inf \left\{n>T\left(u^{\beta}\right):\left|X_{n}\right| \leq u^{\gamma}\right\} \tag{5.1}
\end{equation*}
$$

where $0<\gamma<\beta<1$. We can then write

$$
\begin{equation*}
\mathfrak{B}=\sum_{n=0}^{T\left(u^{\beta}\right)-1} X_{n}+\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}+\sum_{n=K_{\beta}^{\gamma}(u)}^{\tau_{d}-1} X_{n} . \tag{5.2}
\end{equation*}
$$

We will choose $\beta$ close enough to 1 and $\gamma$ far enough from 1 so that $\beta+\gamma>1$ and we can find $\rho \in(\gamma, \beta)$ such that $\beta-\gamma+\rho>1$. The proof of Theorem 3.1 (1) is based on the following steps.

- On the event $\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}$, the first and the last term on the right hand side (r.h.s.) of (5.2) are negligible in contributing to the tail asymptotics. Proposition 5.1 below proves such properties. Lemma 5.5 is useful in showing Proposition 5.1.
- In view of the previous bullet, the second term on the r.h.s. of (5.2) plays the key role in $\mathbf{P}(\mathfrak{B}>u)$. Our analysis relies on the fact that the Markov chain $X_{n}$ resembles a multiplicative random walk in the corresponding regime. Proposition 5.2 below proves such asymptotics. Lemmas 5.6, 5.7 are helpful for proving Proposition 5.2.

Similarly, the proof of Theorem 3.1 (2) hinges on Propositions 5.3 and 5.4, which play the similar roles as Proposition 5.1 and 5.2, respectively.
Proposition 5.1. Suppose that Assumptions 2.1 and 2.4 hold. There exist a $\beta<1$ and $0<\gamma<\beta$ such that

$$
\mathbf{P}\left(\left|\sum_{n=0}^{T\left(u^{\beta}\right)-1} X_{n}\right|>u, T\left(u^{\beta}\right)<\tau_{d}\right) \text { and } \mathbf{P}\left(\left|\sum_{n=K_{\beta}^{\gamma}(u)}^{\tau_{d}-1} X_{n}\right|>u, T\left(u^{\beta}\right)<\tau_{d}\right)
$$

are of order $o\left(u^{-\alpha}\right)$ as $u \rightarrow \infty$.
Proposition 5.2. Suppose that Assumptions 2.1 and 2.4 hold. There exist $0<\gamma<\beta<1$ (identical to those in Proposition 5.1) such that

$$
\begin{aligned}
& \lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>u, T\left(u^{\beta}\right)<\tau_{d}\right)=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right] \\
& \text { and } \lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}<-u, T\left(u^{\beta}\right)<\tau_{d}\right)=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{-}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right] .
\end{aligned}
$$

Proof of Theorem 3.1 (1). Recalling $T\left(u^{\beta}\right)=\inf \left\{n \geq 0:\left|X_{n}\right|>u^{\beta}\right\}$ for $\beta \in(0,1)$, write

$$
\begin{equation*}
\mathbf{P}( \pm \mathfrak{B}>u)=\mathbf{P}\left( \pm \mathfrak{B}>u, T\left(u^{\beta}\right)<\tau_{d}\right)+\mathbf{P}\left( \pm \mathfrak{B}>u, T\left(u^{\beta}\right) \geq \tau_{d}\right) \tag{5.3}
\end{equation*}
$$

Since $\mathbf{P}\left(\tau_{d}>n\right)$ decays geometrically in $n$ since $\left|X_{0}\right| \leq d$, and $\left|X_{n}\right| \leq u^{\beta}$ for $n \leq \tau_{d}-1$ on $T\left(u^{\beta}\right) \geq \tau_{d}$, we have that

$$
\mathbf{P}\left( \pm \mathfrak{B}>u, T\left(u^{\beta}\right) \geq \tau_{d}\right) \leq \mathbf{P}\left(|\mathfrak{B}|>u, T\left(u^{\beta}\right) \geq \tau_{d}\right) \leq \mathbf{P}\left(\sum_{n=0}^{\tau_{d}-1}\left|X_{n}\right|>u, T\left(u^{\beta}\right) \geq \tau_{d}\right)
$$

Large deviations for heavy-tailed Markov-additive processes

$$
\begin{equation*}
\leq \mathbf{P}\left(u^{\beta} \tau_{d} \geq u\right)=\mathbf{P}\left(\tau_{d} \geq u^{1-\beta}\right)=o\left(u^{-\alpha}\right) \tag{5.4}
\end{equation*}
$$

Using (5.3) and (5.4), we can focus on analyzing the first term on the r.h.s. of (5.3). For $0<\gamma<\beta<1$, recall $K_{\beta}^{\gamma}(u)=\inf \left\{n>T\left(u^{\beta}\right):\left|X_{n}\right| \leq u^{\gamma}\right\}$. Using the decomposition in (5.2) and Proposition 5.1, we obtain that, for $\epsilon \in(0,1)$,

$$
\begin{align*}
\mathbf{P}\left(\mathfrak{B}>u, T\left(u^{\beta}\right)<\tau_{d}\right) \leq & \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>(1-\epsilon) u, T\left(u^{\beta}\right)<\tau_{d}\right) \\
& +\mathbf{P}\left(\left|\sum_{n=0}^{T\left(u^{\beta}\right)-1} X_{n}\right|>\frac{\epsilon u}{2}, T\left(u^{\beta}\right)<\tau_{d}\right) \\
& +\mathbf{P}\left(\left|\sum_{n=K_{\beta}^{\gamma}(u)}^{\tau_{d}-1} X_{n}\right|>\frac{\epsilon u}{2}, T\left(u^{\beta}\right)<\tau_{d}\right) \\
= & \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>(1-\epsilon) u, T\left(u^{\beta}\right)<\tau_{d}\right)+o\left(u^{-\alpha}\right) \tag{5.5}
\end{align*}
$$

and

$$
\begin{align*}
\mathbf{P}\left(\mathfrak{B}>u, T\left(u^{\beta}\right)<\tau_{d}\right) \geq & \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>(1+\epsilon) u, T\left(u^{\beta}\right)<\tau_{d}\right) \\
& -\mathbf{P}\left(\left|\sum_{n=0}^{T\left(u^{\beta}\right)-1} X_{n}\right|>\frac{\epsilon u}{2}, T\left(u^{\beta}\right)<\tau_{d}\right) \\
& -\mathbf{P}\left(\left|\sum_{n=K_{\beta}^{\gamma}(u)}^{\tau_{d}-1} X_{n}\right|>\frac{\epsilon u}{2}, T\left(u^{\beta}\right)<\tau_{d}\right) \\
= & \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>(1+\epsilon) u, T\left(u^{\beta}\right)<\tau_{d}\right)+o\left(u^{-\alpha}\right) . \tag{5.6}
\end{align*}
$$

From (5.5), (5.6), and Proposition 5.2,

$$
\begin{aligned}
u^{\alpha} \mathbf{P}\left(\mathfrak{B}>u, T\left(u^{\beta}\right)<\tau_{d}\right) \geq(1+\epsilon)^{-\alpha} C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right]+o(1) ; \\
u^{\alpha} \mathbf{P}\left(\mathfrak{B}>u, T\left(u^{\beta}\right)<\tau_{d}\right) \leq(1-\epsilon)^{-\alpha} C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right]+o(1) .
\end{aligned}
$$

Since $\epsilon$ is arbitrary,

$$
u^{\alpha} \mathbf{P}\left(\mathfrak{B}>u, T\left(u^{\beta}\right)<\tau_{d}\right)=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right]+o(1)
$$

Along with (5.3), (5.4), this proves the first limit of Theorem 3.2 (1):

$$
u^{\alpha} \mathbf{P}(\mathfrak{B}>u)=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right]+o(1)
$$

We can use similar estimates to "sandwich" the quantity $\mathbf{P}(\mathfrak{B}<-u)$ and establish the second limit of Theorem 3.2 (1).

Now we move on to proving Theorem 3.1 (2). We first need the following propositions.

Proposition 5.3. Let Assumptions 2.1 and 2.4 hold. There exist $0<\gamma<\beta<1$ such that

$$
\mathbf{P}\left(\left|\sum_{n=0}^{T\left(u^{\beta}\right)-1} X_{n}\right|>u, T\left(u^{\beta}\right)<r_{1}\right) \quad \text { and } \quad \mathbf{P}\left(\left|\sum_{n=K_{\beta}^{\gamma}(u)}^{r_{1}-1} X_{n}\right|>u, T\left(u^{\beta}\right)<r_{1}\right)
$$

are of order $o\left(u^{-\alpha}\right)$ as $u \rightarrow \infty$.
Proposition 5.4. Let Assumptions 2.1 and 2.4 hold. There exist $0<\gamma<\beta<1$ (the same as in Proposition 5.3) such that

$$
\begin{aligned}
& \lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>u, T\left(u^{\beta}\right)<r_{1}\right)=C_{+} \\
& \text {and } \lim _{u \rightarrow \infty} u^{\alpha} \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}<-u, T\left(u^{\beta}\right)<r_{1}\right)=C_{-},
\end{aligned}
$$

where $C_{+}=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{r_{1}=\infty\right\}}\right]$ and $C_{+}=C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{-}\right)^{\alpha} \mathbb{1}_{\left\{r_{1}=\infty\right\}}\right]$.
Proof of Theorem 3.1 (2). Using similar arguments as in (5.3) and (5.4), we can focus on $\mathbf{P}\left( \pm \mathfrak{R}>u, T\left(u^{\beta}\right)<r_{1}\right)$. Combining the similar "sandwich" technique as in (5.5) and (5.6) with Proposition 5.3, it remains to analyze

$$
u^{\alpha} \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>u, T\left(u^{\beta}\right)<r_{1}\right)
$$

Using Proposition 5.4, we conclude the proof.
Next we prove Proposition 5.1. For this, we need the following lemma. Let $\left\{Y_{n}\right\}_{n \geq 0}$ be the $\mathbb{R}_{+}$-valued Markov chain defined by $Y_{n+1}=A_{n+1} Y_{n}+\left|B_{n+1}\right|$, for $n \geq 0$, and $\tau=\inf \left\{n \geq 1: Y_{n} \leq d\right\}$.
Lemma 5.5. Suppose that Assumptions 2.1 and 2.4 hold. Let $L>0$ be given, and let $\epsilon>0$ be such that $\lfloor\alpha-\epsilon\rfloor \geq 1$. Then there exists a positive constant $c$ such that, for sufficiently large $x$,

$$
\mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=x\right] \leq c x^{\lfloor\alpha-\epsilon\rfloor}
$$

In particular $\mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=x\right]=\mathcal{O}(x)$.
Proof of Proposition 5.1. To begin with, note that

$$
\begin{aligned}
\mathbf{P}\left(\left|\sum_{n=0}^{T\left(u^{\beta}\right)-1} X_{n}\right|>u, T\left(u^{\beta}\right)<\tau_{d}\right) & \leq \mathbf{P}\left(\sum_{n=0}^{T\left(u^{\beta}\right)-1}\left|X_{n}\right|>u, T\left(u^{\beta}\right)<\tau_{d}\right) \\
& \leq \mathbf{P}\left(u^{\beta} \tau_{d}>u\right)=\mathbf{P}\left(\tau_{d}>u^{1-\beta}\right),
\end{aligned}
$$

which decays exponentially. It remains to show the second claim. Let $\rho$ be a number such that $\rho \in(\gamma, \beta)$ and $\beta-\gamma+\rho>1$, and define

$$
\mathfrak{E}_{1}(u)=\left\{\exists n \text { such that } K_{\beta}^{\gamma}(u) \leq n \leq \tau_{d} \text { and }\left|X_{n}\right| \geq u^{\rho}\right\} .
$$

Note that

$$
\mathbf{P}\left(\left|\sum_{n=K_{\beta}^{\gamma}(u)}^{\tau_{d}-1} X_{n}\right|>u, T\left(u^{\beta}\right)<\tau_{d}\right) \leq \mathbf{P}\left(\sum_{n=K_{\beta}^{\gamma}(u)}^{\tau_{d}-1}\left|X_{n}\right|>u, T\left(u^{\beta}\right)<\tau_{d}, \mathfrak{E}_{1}(u)\right)
$$

Large deviations for heavy-tailed Markov-additive processes

$$
+\mathbf{P}\left(\sum_{n=K_{\beta}^{\gamma}(u)}^{\tau_{d}-1}\left|X_{n}\right|>u, T\left(u^{\beta}\right)<\tau_{d},\left(\mathfrak{E}_{1}(u)\right)^{c}\right)
$$

where the second term in the last equation is bounded by $\mathbf{P}\left(\tau_{d}>u^{1-\rho}\right)$, and hence is of order $o\left(u^{-\alpha}\right)$. It remains to analyze the first term, which is bounded by $\mathbf{P}\left(T\left(u^{\beta}\right)<\right.$ $\left.\tau_{d}, \mathfrak{E}_{1}(u)\right)$. Our goal here is to show that

$$
\begin{equation*}
\mathbf{P}\left(T\left(u^{\beta}\right)<\tau_{d}, \mathfrak{E}_{1}(u)\right)=o\left(u^{-\alpha}\right), \quad \text { as } u \rightarrow \infty . \tag{5.7}
\end{equation*}
$$

To begin with, note that, on $\mathfrak{E}_{1}(u)$, where $K_{\beta}^{\gamma}(u)<\infty$ almost surely, we can define $\left\{Y_{n}^{\prime}\right\}_{n \geq 0}$ as follows

Y_{0}^{\prime}=u^{\gamma}, \quad Y_{n+1}^{\prime}=A_{K_{\beta}^{\gamma}(u)+n+1} Y_{n}^{\prime}+\left|B_{K_{\beta}^{\gamma}(u)+n+1}\right|, \quad \text { for } n \geq 0
$$

so that $\left|X_{K_{\beta}^{\gamma}(u)+n}\right| \leq Y_{n}^{\prime}$, for all $n \geq 0$. Let $\tau^{\prime} \triangleq \inf \left\{n \geq 1: Y_{n}^{\prime} \leq d\right\}$. Since $\mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}} \in$ $m \mathcal{F}_{T\left(u^{\beta}\right)}$, and $Y_{n}^{\prime}$ is well-defined on $\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}$ (since $K_{\beta}^{\gamma}(u)<\infty \mathbf{P}$-almost surely there), we have that

\mathbf{P}\left(T\left(u^{\beta}\right)<\tau_{d}, \mathfrak{E}_{1}(u)\right) & \leq \mathbf{P}\left(T\left(u^{\beta}\right)<\tau_{d}, \exists n \leq \tau^{\prime} \text { such that } Y_{n}^{\prime} \geq u^{\rho}\right) \\
& =\mathbf{P}\left(T\left(u^{\beta}\right)<\tau_{d}\right) \mathbf{P}\left(\exists n \leq \tau^{\prime} \text { such that } Y_{n}^{\prime} \geq u^{\rho} \mid T\left(u^{\beta}\right)<\tau_{d}\right), \tag{5.8}
\end{align*}
$$

where $\mathbf{P}\left(T\left(u^{\beta}\right)<\tau_{d}\right)=\mathcal{O}\left(u^{-\alpha \beta}\right)$ (cf. Corollary 4.2 of [13]). Since we have chosen $\beta, \gamma$, and $\rho$ in such a way that $\beta-\gamma+\rho>1$, it remains to show that the second term on the r.h.s. is $\mathcal{O}\left(u^{-\alpha(\rho-\gamma)}\right)$. Recall the definition of $Y_{n}$ and $\tau$, and note that from the strong Markov property,

& =\mathbf{P}\left(T<\tau \mid Y_{0}=u^{\gamma}\right)=\mathbf{E}^{\alpha}\left[e^{-\alpha S_{T}} \mathbb{1}_{\{T<\tau\}} \mid Y_{0}=u^{\gamma}\right] \\
& =u^{-\alpha(\rho-\gamma)} \mathbf{E}^{\alpha}\left[\left.\left(\frac{Y_{T}}{u^{\rho}}\right)^{-\alpha}\left(\frac{Y_{T}}{e^{S_{T}} u^{\gamma}}\right)^{\alpha} \mathbb{1}_{\{T<\tau\}} \right\rvert\, Y_{0}=u^{\gamma}\right] \\
& \leq u^{-\alpha(\rho-\gamma)} \mathbf{E}^{\alpha}\left[\left.\left(\frac{Y_{T}}{e^{S_{T}} u^{\gamma}}\right)^{\alpha} \mathbb{1}_{\{T<\tau\}} \right\rvert\, Y_{0}=u^{\gamma}\right] .
\end{aligned}
$$

Now it is sufficient to show that

$$
\begin{equation*}
\limsup _{u \rightarrow \infty} \mathbf{E}^{\alpha}\left[\left.\left(\frac{Y_{T}}{e^{S_{T}} u^{\gamma}}\right)^{\alpha} \mathbb{1}_{\{T<\tau\}} \right\rvert\, Y_{0}=u^{\gamma}\right]<\infty \tag{5.9}
\end{equation*}
$$

to prove that the r.h.s. of (5.8) is $\mathcal{O}\left(u^{-\alpha(\rho-\gamma)}\right)$, and hence, $\mathbf{P}\left(T\left(u^{\beta}\right)<\tau_{d}, \mathfrak{E}_{1}(u)\right)=o\left(u^{-\alpha}\right)$. To show (5.9), note that

\frac{Y_{T}}{e^{S_{T}} u^{\gamma}}=e^{-S_{T}} u^{-\gamma}\left(e^{S_{T}} u^{\gamma}+e^{S_{T}} \sum_{k=1}^{T}\left|B_{k}\right| e^{-S_{k}}\right)=1+u^{-\gamma} \sum_{k=1}^{T}\left|B_{k}\right| e^{-S_{k}} .

Thus, we have that

\frac{Y_{T}}{e^{S_{T}} u^{\gamma}} \mathbb{1}_{\{T<\tau\}} \leq 1+u^{-\gamma} \sum_{k=1}^{T}\left|B_{k}\right| e^{-S_{k}} \mathbb{1}_{\{T<\tau\}} \leq 1+u^{-\gamma} \sum_{k=1}^{\infty}\left|B_{k}\right| e^{-S_{k}} \mathbb{1}_{\{k<\tau\}}
$$

and hence,

$$
\begin{align*}
& \mathbf{E}^{\alpha}\left[\left.\left(\frac{Y_{T}}{e^{S_{T}} u^{\gamma}} \mathbb{1}_{\{T<\tau\}}\right)^{\alpha} \right\rvert\, Y_{0}=u^{\gamma}\right]^{1 / \alpha} \\
& \leq \mathbf{E}^{\alpha}\left[\left(1+u^{-\gamma} \sum_{k=1}^{\infty}\left|B_{k}\right| e^{-S_{k}} \mathbb{1}_{\{k<\tau\}}\right)^{\alpha} \mid Y_{0}=u^{\gamma}\right]^{1 / \alpha} \\
& \leq 1+\sum_{k=1}^{\infty} \mathbf{E}^{\alpha}\left[u^{-\alpha \gamma}\left|B_{k}\right|^{\alpha} e^{-\alpha S_{k}} \mathbb{1}_{\{k<\tau\}} \mid Y_{0}=u^{\gamma}\right]^{1 / \alpha}  \tag{5.10}\\
& =1+u^{-\gamma} \sum_{k=1}^{\infty} \mathbf{E}^{\alpha}\left[e^{-\alpha S_{k}}\left|B_{k}\right|^{\alpha} \mathbb{1}_{\{k<\tau\}} \mid Y_{0}=u^{\gamma}\right]^{1 / \alpha} \\
& =1+u^{-\gamma} \sum_{k=1}^{\infty} \mathbf{E}\left[\left|B_{k}\right|^{\alpha} \mathbb{1}_{\{k<\tau\}} \mid Y_{0}=u^{\gamma}\right]^{1 / \alpha}  \tag{5.11}\\
& \leq 1+u^{-\gamma} \sum_{k=1}^{\infty}\left(\mathbf{E}\left|B_{k}\right|^{\alpha}\right)^{1 / \alpha} \mathbf{P}\left(\tau \geq k \mid Y_{0}=u^{\gamma}\right)^{1 / \alpha}  \tag{5.12}\\
& \leq 1+u^{-\gamma}\left(\mathbf{E}\left|B_{1}\right|^{\alpha}\right)^{1 / \alpha}\left(\mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=u^{\gamma}\right]\right)^{1 / \alpha} \sum_{k=1}^{\infty} k^{-(\alpha+L) / \alpha}, \tag{5.13}
\end{align*}
$$

for some $L>0$, where (5.10) is from Fatou's lemma and Minkowski's inequality, (5.11) is from Remark 2.8 with $T=k$ and $R=\left|B_{k}\right|^{\alpha} \mathbb{1}_{\{k<\tau\}}$, (5.12) is from the fact that $\mathbb{1}_{\{k<\tau\}} \leq$ $\mathbb{1}_{\{k \leq \tau\}}$ and $\mathbb{1}_{\{k \leq \tau\}} \in m \mathcal{F}_{k-1}$ so that $\mathbb{1}_{\{k \leq \tau\}}$ and $\left|B_{k}\right|^{\alpha}$ are independent, and (5.13) is from Markov's inequality. Using Lemma 5.5 above, we prove (5.9), which, in turn, proves (5.7). This concludes the proof of Proposition 5.1.

Set

\mathscr{G}_{+}(u)=u^{(1-\beta) \alpha} \mathbf{P}^{\left.\mathscr{D}_{T(u)}^{\alpha}\right)}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>u \mid \mathcal{F}_{T\left(u^{\beta}\right)}\right)\left(\frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}\right)^{-\alpha} \mathbb{1}_{\left\{Z_{T\left(u^{\beta}\right)}>0\right\}}, \tag{5.14}
\end{equation*}
$$

and

\mathscr{G}_{-}(u)=u^{(1-\beta) \alpha} \mathbf{P}^{\mathscr{D}_{T\left(u^{\beta}\right)}^{\alpha}}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>u \mid \mathcal{F}_{T\left(u^{\beta}\right)}\right)\left|\frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}\right|^{-\alpha} \mathbb{1}_{\left\{Z_{T\left(u^{\beta}\right)} \leq 0\right\}} . \tag{5.15}
\end{equation*}

Recall $C_{\infty}$ in (3.3). The following two lemmas are useful in proving Proposition 5.2.

Recall that $Z_{n}, \tau_{d}$, and $T(u)$ are defined in (2.6), (3.1), and (5.1), respectively.
Lemma 5.7. Suppose that Assumptions 2.1 and 2.4 hold. The random variables $Z_{T\left(u^{\beta}\right)}^{+} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}$ and $Z_{T\left(u^{\beta}\right)}^{-} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}$ are bounded by

In addition, $\mathbf{E}^{\alpha}\left[\bar{Z}^{\alpha}\right]<\infty$.

Proof of Proposition 5.2. We focus on deriving the first asymptotics, since the second one follows using similar arguments. Note that

& +u^{\alpha} \mathbf{P}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>u, X_{T\left(u^{\beta}\right)}<0, T\left(u^{\beta}\right)<\tau_{d}\right) \\
= & (\mathbf{I} . \mathbf{1})+\mathbf{( \mathbf { I } . 2 )} . \tag{5.16}
\end{align*}
$$

We first consider (I.1). Applying the dual change of measure $\mathscr{D}_{T\left(u^{\beta}\right)}^{\alpha}$ together with Result 2.7, we obtain that

where

g_{\tau_{d}-1}\left(X_{0}, X_{1}, \ldots, X_{\tau_{d}-1}\right)= \begin{cases}1 & \text { if } \sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{n}>u \text { and } X_{T\left(u^{\beta}\right)}>0 \\ 0 & \text { otherwise }\end{cases}
$$

Recall the expression for $Z_{n}$ given in (2.6). Note that

\mathbf{( I . 1 )} & =u^{\alpha} \mathbf{E}^{\mathscr{D}_{T\left(u^{\beta}\right)}^{\alpha}}\left[g_{\tau_{d}-1}\left(X_{0}, \ldots, X_{\tau_{d}-1}\right) e^{\left.-\alpha S_{T\left(u^{\beta}\right)} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}\right]}\right. \\
& =u^{\alpha} \mathbf{E}^{\mathscr{D}_{T\left(u^{\beta}\right)}^{\alpha}}\left[g_{\tau_{d}-1}\left(X_{0}, \ldots, X_{\tau_{d}-1}\right) \cdot\left|X_{T\left(u^{\beta}\right)}\right|^{-\alpha} \cdot\left|X_{T\left(u^{\beta}\right)}\right|^{\alpha} \cdot e^{\left.-\alpha S_{T\left(u^{\beta}\right)} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}\right]}\right. \\
& =\mathbf{E}^{\mathscr{D}_{T\left(u^{\beta}\right)}^{\alpha}}\left[\mathscr{G}_{+}(u)\left(Z_{T\left(u^{\beta}\right)}^{+}\right)^{\alpha} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}\right] \tag{5.17}
\end{align*}
$$

for all $n \geq 0$. Using Lemma 5.6, Lemma 5.7, the dominated convergence theorem and the fact that $T\left(u^{\beta}\right) \rightarrow \infty$ as $u \rightarrow \infty$, we obtain that

& =\lim _{u \rightarrow \infty} \mathbf{E}^{\alpha}\left[\left(Z_{T\left(u^{\beta}\right)}^{+}\right)^{\alpha} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}} \mathscr{G}_{+}(u)\right] \\
& =\mathbf{E}^{\alpha}\left[\lim _{u \rightarrow \infty}\left(Z_{T\left(u^{\beta}\right)}^{+}\right)^{\alpha} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}} \mathscr{G}_{+}(u)\right]=\mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}} C_{\infty}\right] \\
& =C_{\infty} \mathbf{E}^{\alpha}\left[\left(Z^{+}\right)^{\alpha} \mathbb{1}_{\left\{\tau_{d}=\infty\right\}}\right] .
\end{aligned}
$$

Analogously, we have that

\mathbf{( \mathbf { I } . 2 )}=\mathbf{E}^{\mathscr{D}_{T\left(u^{\beta}\right)}^{\alpha}}\left[\left(Z_{T\left(u^{\beta}\right)}^{-}\right)^{\alpha} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}} \mathscr{G}_{-}(u)\right] \rightarrow 0, \quad \text { as } u \rightarrow \infty \tag{5.18}
\end{equation*}
$$

where $\mathscr{G}_{-}(u)$ was defined in (5.15). Using (5.16), (5.17), and (5.18), we prove the first asymptotics in Proposition 5.2. The second one can be shown analogously.

We need the following lemmas to prove Proposition 5.3. Let $Y_{n+1}=A_{n+1} Y_{n}+\left|B_{n+1}\right|$ and let $r$ be the first time that $Y_{n}$ regenerates.
Lemma 5.8. Suppose that Assumptions 2.1 and 2.4 hold. Let $\epsilon>0$, and let $L>0$ be such that $\lfloor\alpha-\epsilon\rfloor \geq 1$. Then there exists a positive constant $c$ such that, for sufficiently large $x$,

where $\mathfrak{X}$ is the positive random variable such that $\log X_{T(u)}-\log u$ converges in distribution to $\mathfrak{X}$ as $u \rightarrow \infty$ under $\mathbf{P}^{\alpha}$.

Proof of Proposition 5.3. By replacing $\tau_{d}$ with $r_{1}$, the proposition can be shown using almost identical arguments as in the proof of Proposition 5.1. Nonetheless, we need to show that

- $\mathbf{P}\left(T\left(u^{\beta}\right)<r_{1}\right) \sim c u^{-\alpha \beta}$ for some constant $c$, and that
- $\mathbf{E}\left[r^{\alpha+\epsilon} \mid Y_{0}=x\right]=\mathcal{O}(x)$, where $Y_{n+1}=A_{n+1} Y_{n}+\left|B_{n+1}\right|$ and $r-1$ is the first time that $\left(Y_{n}, \eta_{n}\right)$ returns to the set $[-d, d] \times\{1\}$.

For this, we use Lemmas 5.8 and 5.9 above.
Proof of Proposition 5.4. Using Lemma 5.6, Lemma 5.7, the dominated convergence theorem and the fact that $T\left(u^{\beta}\right) \rightarrow \infty$ as $u \rightarrow \infty$, one can prove the first asymptotics. The second one follows by a similar analysis.

Next we provide proofs of all lemmas in this section. To show Lemma 5.5, we introduce a result on bounding functionals of passage times for Markov chains. Let $\left\{V_{n}\right\}_{n \geq 0}$ be an $\left\{\mathcal{F}_{n}\right\}$-adapted stochastic process taking values in an unbounded subset of $\mathbb{R}_{+}$. Let $\left\{U_{n}\right\}_{n \geq 0}$ be another $\left\{\mathcal{F}_{n}\right\}$-adapted stochastic process taking values in an unbounded subset of $\mathbb{R}_{+}$such that $U_{n}$ is integrable for all $n \geq 0$. Let $\tau_{b}^{V}=\inf \{n \geq$ $\left.0: V_{n} \leq b\right\}$ be the first time $V_{n}$ returning to the set $[0, b]$.
Result 5.10 (Theorem $2^{\prime}$ of [1]). Suppose there exists a positive number $d$ and functions $g$ and $h$ that are positive on $(b, \infty)$,

U_{n} \leq h\left(V_{n}\right), \quad \forall n \geq 0
$$

and

$$
\mathbf{E}\left[U_{n+1}-U_{n} \mid \mathcal{F}_{n}\right] \leq-g\left(V_{n}\right) \quad \text { on } \quad\left\{\tau_{b}^{V}>n\right\}
$$

Suppose in addition that $f$ is a function on $[0, \infty]$ such that

- $f \in C^{2}, f>0, f^{\prime}>0, \lim _{x \rightarrow \infty} f(x)=\infty$,
- $f$ is convex for sufficiently large $x$,
- $\log f^{\prime}$ is concave for sufficiently large $x$,
- $f$ satisfies

\liminf _{y \rightarrow \infty} \frac{g(y)}{f^{\prime} \circ f^{-1} \circ h(y)}>0
$$

- there exists a positive constant $c_{f}$ such that

\limsup _{y \rightarrow \infty} \frac{f(2 y)}{f(y)} \leq c_{f}
$$

Then there exists a positive constant $c$ such that, for all $x \geq b$

\mathbf{E}\left[f\left(\tau_{b}^{V}\right) \mid V_{0}=x\right] \leq \operatorname{ch}(x)
$$

Proof of Lemma 5.5. We first apply Result 5.10 with $f(y)=y^{\alpha+L}, g(y)=c_{2} y^{\underline{\alpha}}, h(y)=y^{\underline{\alpha}}$ where $\underline{\alpha}=\lfloor\alpha-\epsilon\rfloor$, and $c_{2}$ is a constant that we construct below, $U_{n}=h\left(Y_{n}\right), V_{n}=Y_{n}$, and $\mathcal{F}_{n}=\sigma\left(Y_{i}: i \leq n\right)$. From the binomial formula, we see that there exist positive constants $c_{1}$ that depends on the first $(\underline{\alpha}-1)$-st moments of $A_{1}$ and $B_{1}$ such that, on $\left\{Y_{n} \geq 1\right\}$,

$$
\mathbf{E}\left[U_{n+1}-U_{n} \mid \mathcal{F}_{n}\right] \leq\left(\mathbf{E}\left[A_{1}^{\frac{\alpha}{1}}\right]-1\right) Y_{n}^{\underline{\alpha}}+c_{1} Y_{n}^{\underline{\alpha}-1}
$$

Using the fact that $0<\underline{\alpha}<\alpha$ and the moment generating function of $\log A_{1}$ is strictly convex on $[0, \alpha]$, we have $\mathbf{E}\left[A_{1}^{\alpha}\right]<1$. Thus, there exists a sufficiently large constant $d^{\prime}$ and sufficiently small constant $c_{2}$ such that, on $\left\{Y_{n}>d^{\prime}\right\}$,

$$
\mathbf{E}\left[U_{n+1}-U_{n} \mid \mathcal{F}_{n}\right] \leq\left(\mathbf{E}\left[A_{1}^{\underline{\alpha}}\right]-1\right) Y_{n}^{\underline{\alpha}}+c_{1} Y_{n}^{\underline{\alpha}-1} \leq-c_{2} Y_{n}^{\underline{\alpha}}
$$

As mentioned at the beginning of the proof, we set $g(y)=c_{2} y^{\underline{\alpha}}=c_{2} h(y)$ so that

$$
\mathbf{E}\left[U_{n+1}-U_{n} \mid \mathcal{F}_{n}\right] \leq-g\left(Y_{n}\right)
$$

It is now straightforward to check that $f, g$, and $h$ satisfy all the conditions in Result 5.10. If we set $\tilde{\tau}=\inf \left\{n \geq 1: Y_{n} \leq d^{\prime}\right\}$, Result 5.10 implies that there exists a positive constant $c_{3}$ such that

\begin{equation*}
\mathbf{E}\left[\tilde{\tau}^{\alpha+L} \mid Y_{0}=x\right] \leq c_{3} x^{\lfloor\alpha-\epsilon\rfloor} \tag{5.19}
\end{equation*}
$$

for all $x \geq d^{\prime}$. We assume w.l.o.g. that $d^{\prime} \geq d$. Note that $Y_{n}$ satisfies the same set assumptions as $X_{n}$, and hence, Lemma 2.6 applies to $Y_{n}$ as well, and $\tau$ is bounded by the regeneration time of $Y_{n}$. Therefore, we can choose a $t$ so that

\sup _{y \in\left[0, d^{\prime}\right]} \mathbf{E}\left[t^{\tau} \mid Y_{0}=y\right]^{1 /(\alpha+L)}<\infty .
$$

Using Minkowski's inequality we obtain that

& \leq \mathbf{E}\left[\tilde{\tau}^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+\mathbf{E}\left[(\tau-\tilde{\tau})^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)} \\
& \leq \mathbf{E}\left[\tilde{\tau}^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+\sup _{y \in\left[0, d^{\prime}\right]} \mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=y\right]^{1 /(\alpha+L)} \\
& \leq \mathbf{E}\left[\tilde{\tau}^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+\sup _{y \in\left[0, d^{\prime}\right]} \mathbf{E}\left[t^{\tau} \mid Y_{0}=y\right]^{1 /(\alpha+L)}+c_{4}, \\
& \leq \mathbf{E}\left[\tilde{\tau}^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+c_{5}
\end{aligned}
$$

for some $c_{4}, c_{5}>0$. Along with (5.19), this implies that there exists a $c>0$ such that $\mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=x\right] \leq c x^{\lfloor\alpha-\epsilon\rfloor}$ for sufficiently large $x$.

The following lemma is useful in proving Lemma 5.6. Define

\mathfrak{E}_{2}(u)=\left\{\left|B_{n}\right| \leq u^{\gamma}, \forall n \in\left\{1, \ldots, K_{\beta}^{\gamma}(u)\right\}\right\} . \tag{5.20}

Lemma 5.11. Suppose that Assumptions 2.1 and 2.4 hold. Fix an arbitrary constant $v$ such that $|v|>1$. For any $\beta+\gamma>1$ and any $\epsilon>0$ there exists a $u_{0}$ sufficiently large so that, for all $u \geq u_{0}$,

Proof of Lemma 5.6. We first prove the statements associated with $\mathscr{G}_{+}(u)$. As $\mathbb{1}_{\left.\left\{Z_{T(u)}\right)>0\right\}} \xrightarrow{\text { a.s. }} \mathbb{1}_{\{Z>0\}}$ under $\mathbf{P}^{\alpha}$, it is sufficient to show that

\lim _{u \rightarrow \infty} u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right)=C_{\infty} v^{\alpha}, \quad \text { for } v>1 .
$$

## Large deviations for heavy-tailed Markov-additive processes

Set $S_{n}^{(u)} \triangleq \sum_{i=1}^{n} \log \left(A_{i}+u^{-\gamma} \cdot\left|B_{i}\right|\right)$ and fix $v \geq 1$. Note that since

\frac{X_{n}}{X_{n-1}} \leq A_{n}+\frac{\left|B_{n}\right|}{\left|X_{n-1}\right|}<A_{n}+\left|B_{n}\right| u^{-\gamma} \quad \text { on } \quad T\left(u^{\beta}\right)<n<K_{\beta}^{\gamma}(u)
$$

we have that, conditional on $X_{0}=v u^{\beta},\left|X_{k}\right| \leq v u^{\beta} e^{S_{k}^{(u)}}$ for all $k<K_{\beta}^{\gamma}(u)$. Therefore, from the Markov property,

\begin{align*}
& \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right) \\
& \quad=\mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) \\
& \\
& \quad \leq \mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1}\left|X_{k}\right|>u \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) \\
& \\
& \quad \leq \mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} e^{S_{k}^{(u)}>} \frac{u^{1-\beta}}{v}\right) \leq \mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}>\frac{u^{1-\beta}}{v}\right)  \tag{5.21}\\
& \quad=\mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}+\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}-\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}\right) \\
& \quad \leq \mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}-\delta\right)+\mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}-\sum_{k=0}^{\infty} e^{S_{k}}>\delta\right)
\end{align*}
$$

for any $\delta>0$. Note that from (3.3),

$$
\begin{equation*}
\mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}-\delta\right) \sim C_{\infty}\left(\frac{u^{1-\beta}}{v}\right)^{-\alpha} \tag{5.22}
\end{equation*}
$$

Moreover, using Markov's inequality and the fact that $S_{n}^{(u)} \geq S_{n}$ we obtain that

$$
\begin{aligned}
u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}-\sum_{k=0}^{\infty} e^{S_{k}}>\delta\right) & \leq \delta^{-1} u^{(1-\beta) \alpha} \mathbf{E}\left[\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}-\sum_{k=0}^{\infty} e^{S_{k}}\right] \\
& =\delta^{-1} u^{(1-\beta) \alpha}\left(\sum_{k=0}^{\infty}\left(\mathbf{E}\left[A_{1}+\left|B_{1}\right| u^{-\gamma}\right]\right)^{k}-\sum_{k=0}^{\infty}\left(\mathbf{E}\left[A_{1}\right]\right)^{k}\right) \\
& =\delta^{-1} u^{(1-\beta) \alpha}\left(\frac{1}{1-\mathbf{E} A_{1}-u^{-\gamma} \mathbf{E}\left|B_{1}\right|}-\frac{1}{1-\mathbf{E} A_{1}}\right) \\
& =\delta^{-1} u^{(1-\beta) \alpha}\left(\frac{u^{-\gamma} \mathbf{E}\left|B_{1}\right|}{\left(1-\mathbf{E} A_{1}-u^{-\gamma} \mathbf{E}\left|B_{1}\right|\right)\left(1-\mathbf{E} A_{1}\right)}\right) \\
& =\mathcal{O}\left(u^{(1-\beta) \alpha-\gamma}\right)
\end{aligned}
$$

for sufficiently large $u$. In the second equality, we used $\mathbf{E} A_{1}<1$, (which follows from $\alpha>1)$ and $\mathbf{E}\left(A_{1}+\left|B_{1}\right| u^{-\gamma}\right)<1$ for sufficiently large $u$ 's. By choosing $\beta$ sufficiently close to 1 so that $(1-\beta) \alpha<\gamma$, we have that

u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}-\sum_{k=0}^{\infty} e^{S_{k}}>\delta\right)=o(1) \tag{5.23}

Using (5.21)-(5.23), an upper bound is given by, for $v>1$

\limsup _{u \rightarrow \infty} u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right) \leq C_{\infty} v^{\alpha} . \tag{5.24}
\end{equation*}
$$

Next, we show the corresponding lower bound. By the Markov property we obtain that

\mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right)=\mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) . \tag{5.25}
\end{equation*}
$$

Set $\underline{S}_{n}^{(u)}=\sum_{i=1}^{n} \log \left(A_{i}-u^{-\gamma} \cdot\left|B_{i}\right|\right)^{+}$. Note that, conditional on $X_{0}=v u^{\beta}$

$$
\left|\frac{X_{n}}{X_{n-1}}\right| \geq\left(A_{n}-\frac{\left|B_{n}\right|}{\left|X_{n-1}\right|}\right)^{+}>\left(A_{n}-u^{-\gamma}\left|B_{n}\right|\right)^{+}, \quad \forall n \leq K_{\beta}^{\gamma}(u)
$$

which, in turn, implies that

$$
\begin{equation*}
v u^{\beta} e^{\underline{S}_{k}^{(u)}} \leq\left|X_{k}\right|, \quad \forall k \leq K_{\beta}^{\gamma}(u) \tag{5.26}
\end{equation*}
$$

In particular,

$$
v u^{\beta} e^{\underline{S}_{K_{\beta}^{\gamma}(u)}^{(u)}} \leq\left|X_{K_{\beta}^{\gamma}(u)}\right| \leq u^{\gamma}
$$

Therefore,

$$
\begin{equation*}
K_{\beta}^{\gamma}(u) \geq \inf \left\{n \geq 1: \underline{S}_{n}^{(u)} \leq-\log v-(\beta-\gamma) \log u\right\} \triangleq K^{\prime}(u) \tag{5.27}
\end{equation*}
$$

conditional on $X_{0}=v u^{\beta}$. Recall that $\mathfrak{E}_{2}(u)=\left\{\left|B_{n}\right| \leq u^{\gamma}, \forall n \in\left\{1, \ldots, K_{\beta}^{\gamma}(u)\right\}\right\}$, and note that on $\mathfrak{E}_{2}(u)$ and $X_{0}=v u^{\beta}, X_{k} \geq 0$ for all $k<K_{\beta}^{\gamma}(u)$. To see this, let $\kappa \triangleq \inf \{k \geq 0$ : $\left.X_{k}<0\right\}$ and observe that $\kappa<K_{\beta}^{\gamma}(u)$ implies that $A_{\kappa-1} X_{\kappa-1} \geq 0$ and $X_{\kappa}<-u^{\gamma}$, and hence, $B_{\kappa}<-u^{\gamma}$, leading to a contradiction. In view of this, (5.25), and (5.26), we have

& \geq \mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1}\left|X_{k}\right|>u, \mathfrak{E}_{2}(u) \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) \\
& \geq \mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} e^{\underline{S}_{k}^{(u)}}>\frac{u^{1-\beta}}{v}, \mathfrak{E}_{2}(u) \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) \\
\geq & \mathbf{P}\left(\left.\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} e^{\underline{S}_{k}^{(u)}}>\frac{u^{1-\beta}}{v} \right\rvert\, \frac{X_{0}}{u^{\beta}}=v\right) \\
& -\mathbf{P}\left(\mathfrak{E}_{2}(u)^{c} \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) \\
= & \mathbf{P}\left(\left.\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} e^{\underline{S}_{k}^{(u)}}>\frac{u^{1-\beta}}{v} \right\rvert\, \frac{X_{0}}{u^{\beta}}=v\right)+o\left(u^{\alpha(1-\beta)}\right)|v|,
\end{aligned}
$$

where the last equality is from Lemma 5.11. On the other hand, from (5.27),
$\mathbf{P}\left(\left.\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} e^{\underline{S}_{k}^{(u)}}>\frac{u^{1-\beta}}{v} \right\rvert\, \frac{X_{0}}{u^{\beta}}=v\right) \geq \mathbf{P}\left(\sum_{k=0}^{K^{\prime}(u)-1} e^{\underline{S}_{k}^{(u)}}>\frac{u^{1-\beta}}{v}\right)$

Large deviations for heavy-tailed Markov-additive processes

$$
\begin{equation*}
\geq \mathbf{P}\left(\sum_{k=0}^{\infty} e^{\underline{S}_{k}^{(u)}}>\frac{u^{1-\beta}}{v}+\delta\right)-\mathbf{P}\left(\sum_{k=K^{\prime}(u)}^{\infty} e^{\underline{S}_{k}^{(u)}}>\delta\right) \tag{5.28}
\end{equation*}
$$

for any $\delta>0$. Note that

$$
\begin{aligned}
\mathbf{P}\left(\sum_{k=K^{\prime}(u)}^{\infty} e^{\underline{S}_{k}^{(u)}}>\delta\right) & \leq \delta^{-1} \mathbf{E}\left[\sum_{k=K^{\prime}(u)}^{\infty} e^{\underline{S}_{k}^{(u)}}\right]=\delta^{-1} \mathbf{E}\left[e^{\underline{S}_{K^{\prime}(u)}^{(u)}} \sum_{k=0}^{\infty} e^{\underline{S}_{k+K^{\prime}(u)}^{(u)}-\underline{S}_{K^{\prime}(u)}^{(u)}}\right] \\
& \leq \frac{u^{\gamma-\beta}}{\delta v} \mathbf{E}\left[\sum_{k=0}^{\infty} e^{\underline{S}_{k}^{(u)}}\right] \leq \frac{u^{\gamma-\beta}}{\delta} \mathbf{E}\left[\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}\right] \\
& \leq \frac{u^{\gamma-\beta}}{\delta} \mathbf{E}\left[\sum_{k=0}^{\infty} e^{S_{k}}\right]=o\left(u^{\gamma-\beta}\right),
\end{aligned}
$$

and hence,

\begin{equation*}
u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=K^{\prime}(u)}^{\infty} e^{\underline{S}_{k}^{(u)}}>\delta\right)=o(1), \quad \text { for } \beta>(\alpha+\gamma) /(\alpha+1) \tag{5.29}
\end{equation*}
$$

allowing us to choose a suitable value of $\beta$ since $(\alpha+\gamma) /(\alpha+1)<1$. Therefore, it remains to show that the first term in (5.28) is lower bounded by $C_{\infty} u^{-(1-\beta) \alpha} v^{\alpha}$. Note that

& \geq \mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}+2 \delta\right)-\delta^{-1} \mathbf{E}\left[\sum_{k=0}^{\infty} e^{S_{n}}-\sum_{k=0}^{\infty} e^{\underline{S}_{n}^{(u)}}\right] \\
& =\mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}+2 \delta\right)-\delta^{-1}\left(\sum_{k=0}^{\infty}\left(\mathbf{E} A_{1}\right)^{k}-\sum_{k=0}^{\infty}\left(\mathbf{E}\left(A_{1}-u^{-\gamma}\left|B_{1}^{*}\right|\right)^{+}\right)^{k}\right) \\
& =\mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}+2 \delta\right)-\delta^{-1}\left(\frac{1}{1-\mathbf{E} A_{1}}-\frac{1}{1-\mathbf{E}\left(A_{1}-u^{-\gamma}\left|B_{1}\right|\right)^{+}}\right) \\
& \geq \mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}+2 \delta\right)-\delta^{-1} \frac{\mathbf{E} A_{1}-\mathbf{E}\left(A_{1}-u^{-\gamma}\left|B_{1}\right|\right)^{+}}{\left(1-\mathbf{E} A_{1}\right)\left(1-\mathbf{E}\left(A_{1}-u^{-\gamma}\left|B_{1}\right|\right)^{+}\right)} \\
& \geq \mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}}>\frac{u^{1-\beta}}{v}+2 \delta\right)-\delta^{-1} \frac{u^{-\gamma} \mathbf{E}\left|B_{1}\right|}{\left(1-\mathbf{E} A_{1}\right)\left(1-\mathbf{E}\left(A_{1}-u^{-\gamma}\left|B_{1}\right|\right)^{+}\right)} .
\end{aligned}
$$

Again from (3.3) along with the assumption that $(1-\beta) \alpha<\gamma$, we get

$$
\begin{equation*}
\mathbf{P}\left(\sum_{k=0}^{\infty} e^{S_{k}^{(u)}}>\frac{u^{1-\beta}}{v}+\delta\right) \geq C_{\infty} u^{-(1-\beta) \alpha} v^{\alpha}+o\left(u^{-(1-\beta) \alpha}\right) \tag{5.30}
\end{equation*}
$$

In view of (5.28)-(5.30), we have that

$$
\liminf _{u \rightarrow \infty} u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right) \geq C_{\infty} v^{\alpha} .
$$

Combining this with (5.24) we have that

\lim _{u \rightarrow \infty} u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}\right.\right)\left(\frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}\right)^{-\alpha}=C_{\infty}
$$

$\mathbf{P}^{\alpha}$-almost surely.
Next we show boundedness of $\mathscr{G}_{+}(u)$. Using (5.24), for $\epsilon>0$, and by separately considering $v \leq 1+\epsilon$ and $v \geq 1+\epsilon$, there exists $U(\epsilon)$ (independent of $v$ ) such that

$$
\left(\frac{u^{(1-\beta)}}{v}\right)^{\alpha} \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right) \leq C_{\infty}+\epsilon,
$$

for all $u^{(1-\beta)} \geq v U(\epsilon)$. Moreover, for all $0<u^{(1-\beta)}<v U(\epsilon)$,

$$
\begin{equation*}
u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right) \leq u^{(1-\beta) \alpha} \leq v^{\alpha} U(\epsilon)^{\alpha} \tag{5.31}
\end{equation*}
$$

Thus

$$
u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}=v\right.\right) \leq \max \left\{C_{\infty}+\epsilon, U(\epsilon)^{\alpha}\right\} v^{\alpha}
$$

for all $u>0$. This implies that $\mathscr{G}_{+}(u) \leq \max \left\{C_{\infty}+\epsilon, U(\epsilon)^{\alpha}\right\}<\infty$.
Finally, we show the statements involved with $\mathscr{G}_{-}$. By the Markov property, it is sufficient to show that, for any arbitrary $\epsilon>0$ and $v<-1$

$$
\limsup _{u \rightarrow \infty} u^{(1-\beta) \alpha} \mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) \leq \epsilon|v|^{\alpha} .
$$

Recall $\mathfrak{E}_{2}(u)=\left\{\left|B_{n}\right| \leq u^{\gamma}, \forall 1 \leq n<K_{\beta}^{\gamma}(u)\right\}$ defined in (5.20). We have that

$$
\begin{aligned}
\mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) & \leq \mathbf{P}\left(\sum_{k=0}^{K_{\beta}^{\gamma}(u)-1} X_{k}>u, \mathfrak{E}_{2}(u) \left\lvert\, \frac{X_{0}}{u^{\beta}}=v\right.\right) \\
& +\mathbf{P}\left(\mathfrak{E}_{2}(u)^{c} \mid X_{0}=v u^{\beta}\right) \\
& =\mathbf{P}\left(\mathfrak{E}_{2}(u)^{c} \mid X_{0}=v u^{\beta}\right)=o\left(u^{-(1-\beta) \alpha}\right)|v|,
\end{aligned}
$$

thanks to Lemma 5.11. The boundedness of $\mathscr{G}_{u}^{-}$follows using similar arguments as in (5.31).

Remark 5.12. Using similar arguments as in the proof of Lemma 5.6, one can show that

$$
\lim _{u \rightarrow \infty} u^{(1-\beta) \alpha} \mathbf{P}^{\mathscr{D}}\left(\sum_{n=T\left(u^{\beta}\right)}^{K_{\beta}^{\gamma}(u)-1}\left|X_{n}\right|>u \mid \mathcal{F}_{T\left(u^{\beta}\right)}\right)\left|\frac{X_{T\left(u^{\beta}\right)}}{u^{\beta}}\right|^{-\alpha}=C_{\infty} .
$$

As a consequence of this result, we have that

$$
u^{\alpha} \mathbf{P}\left(\sum_{n=0}^{r_{1}-1}\left|X_{n}\right|>u\right) \rightarrow C_{\infty} \mathbf{E}^{\alpha}\left[|Z|^{\alpha} \mathbb{1}_{\left\{r_{1}=\infty\right\}}\right], \quad u \rightarrow \infty
$$

Proof of Lemma 5.7. Note that $Z_{T\left(u^{\beta}\right)}^{+} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}$ and $Z_{T\left(u^{\beta}\right)}^{-} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}$ are bounded by $\left|Z_{T\left(u^{\beta}\right)} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}\right|$, for which we have that
$\left|Z_{T\left(u^{\beta}\right)} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}}\right| \leq\left|X_{0}\right|+\sum_{n=1}^{T\left(u^{\beta}\right)}\left|B_{n}\right| e^{-S_{n}} \mathbb{1}_{\left\{T\left(u^{\beta}\right)<\tau_{d}\right\}} \leq\left|X_{0}\right|+\sum_{n=1}^{\infty}\left|B_{n}\right| e^{-S_{n}} \mathbb{1}_{\left\{n<\tau_{d}\right\}}=\bar{Z}$.
Moreover, using Minkowski's inequality we have that

$$
\begin{aligned}
\left(\mathbf{E}^{\alpha}\left[\bar{Z}^{\alpha}\right]\right)^{1 / \alpha} & \leq\left(\mathbf{E}\left|X_{0}\right|^{\alpha}\right)^{1 / \alpha}+\sum_{n=1}^{\infty}\left(\mathbf{E}^{\alpha}\left[\left|B_{n}\right|^{\alpha} e^{-\alpha S_{n}} \mathbb{1}_{\left\{n<\tau_{d}\right\}}\right]\right)^{1 / \alpha} \\
& =\left(\mathbf{E}\left|X_{0}\right|^{\alpha}\right)^{1 / \alpha}+\sum_{n=1}^{\infty}\left(\mathbf{E}\left[\left|B_{n}\right|^{\alpha} \mathbb{1}_{\left\{n<\tau_{d}\right\}}\right]\right)^{1 / \alpha} \\
& \leq\left(\mathbf{E}\left|X_{0}\right|^{\alpha}\right)^{1 / \alpha}+\left(\mathbf{E}\left|B_{1}\right|^{\alpha+\epsilon}\right)^{1 /(\alpha+\epsilon)} \sum_{n=1}^{\infty} \mathbf{P}\left(\tau_{d}>n\right)^{\epsilon /(\alpha(\alpha+\epsilon))}<\infty,
\end{aligned}
$$

where in the second last inequality we used Hölder's inequality, and the finiteness follows from the fact that $\mathbf{P}\left(\tau_{d}>n\right)$ decays exponentially in $n$ uniformly in $\left|X_{0}\right| \leq d$, as established in Lemma 2.6.

Proof of Lemma 5.8. Recall that $\tau=\inf \left\{n \geq 1: Y_{n} \leq d\right\}$. Using Minkowski's inequality we obtain that

$$
\begin{aligned}
& \mathbf{E}\left[r^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}=\mathbf{E}\left[(\tau+r-\tau)^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)} \\
& \leq \mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+\mathbf{E}\left[(r-\tau)^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)} \\
& \leq \mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+\sup _{y \in[0, d]} \mathbf{E}\left[r^{\alpha+L} \mid Y_{0}=y\right]^{1 /(\alpha+L)} \\
& \leq \mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+\sup _{y \in[0, d]} \mathbf{E}\left[t^{r} \mid Y_{0}=y\right]^{]^{1 /(\alpha+L)}+\mathcal{O}(1),}
\end{aligned}
$$

as $x \rightarrow \infty$, where, by following the arguments as in the proof of Lemma 2.6, $t$ can be chosen such that $\sup _{y \in[0, d]} \mathbf{E}\left[t^{r} \mid Y_{0}=y\right]<\infty$. For this choice of $t$, we have that

$$
\mathbf{E}\left[r^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)} \leq \mathbf{E}\left[\tau^{\alpha+L} \mid Y_{0}=x\right]^{1 /(\alpha+L)}+\mathcal{O}(1), \quad \text { as } x \rightarrow \infty
$$

Finally, using Lemma 5.5 above we have $\mathbf{E}\left[r^{\alpha+L} \mid Y_{0}=x\right] \leq c x^{\lfloor\alpha-\epsilon\rfloor}$ for sufficiently large $x$.

Proof of Lemma 5.9. Note that both $\left|Z_{T(u)}^{\alpha}\right| \mathbb{1}_{\left\{T(u)<r_{1}\right\}}$ and $\left|Z_{n}^{\alpha}\right| \mathbb{1}_{\left\{n \leq r_{1}\right\}}$ are bounded by

$$
\bar{Z}=\left|X_{0}\right|+\sum_{n=1}^{\infty}\left|B_{n}\right| e^{-S_{n}} \mathbb{1}_{\left\{n<r_{1}\right\}}
$$

whose $\alpha$-th moment is finite thanks to Lemma 5.7. Moreover, note that $\left\{X_{n}\right\}_{n \geq 0}$ is transient in the $\alpha$-shifted measure (cf. Lemma 2.9 above), and hence, $T(u)<\infty$ a.s. Applying a change of measure argument, we obtain that

$$
\begin{aligned}
u^{\alpha} \mathbf{P}\left(T(u)<r_{1}\right) & =u^{\alpha} \mathbf{E}^{\alpha}\left[e^{-\alpha S_{T(u)}} \mathbb{1}_{\left\{T(u)<r_{1}\right\}}\right]=\mathbf{E}^{\alpha}\left[\left|Z_{T(u)}\right|^{\alpha}\left|\frac{X_{T(u)}}{u}\right|^{-\alpha} \mathbb{1}_{\left\{T(u)<r_{1}\right\}}\right] \\
& =\mathbf{E}^{\alpha}\left[\left|Z_{n}\right|^{\alpha} \mathbb{1}_{\{n \leq T(u)\}} \mathbb{1}_{\left\{n \leq r_{1}\right\}} \mathbf{E}^{\alpha}\left[\left.\left|\frac{X_{T(u)}}{u}\right|^{-\alpha} \right\rvert\, \mathcal{F}_{n}\right]\right]
\end{aligned}
$$

Large deviations for heavy-tailed Markov-additive processes

$$
\begin{aligned}
& +\mathbf{E}^{\alpha}\left[\left(\left|Z_{T(u)}\right|^{\alpha} \mathbb{1}_{\left\{T(u)<r_{1}\right\}}-\left|Z_{n}\right|^{\alpha} \mathbb{1}_{\{n \leq T(u)\}} \mathbb{1}_{\left\{n \leq r_{1}\right\}}\right)\left|\frac{X_{T(u)}}{u}\right|^{-\alpha}\right] \\
= & (\mathbf{I I I . 1 )}+\mathbf{( I I . 2 )},
\end{aligned}
$$

where $\left\{\mathcal{F}_{n}\right\}_{n \geq 0}$ is the natural filtration. Since $\left(X_{T(u)} / u\right)^{-\alpha} \leq 1$ and $T(u) \rightarrow \infty$ a.s. as $u \rightarrow \infty$,

$$
\begin{aligned}
\lim _{n \rightarrow \infty} \lim _{u \rightarrow \infty} \text { (II.2) } & \leq \lim _{n \rightarrow \infty} \lim _{u \rightarrow \infty} \mathbf{E}^{\alpha}\left[\left|Z_{T(u)}\right|^{\alpha} \mathbb{1}_{\left\{T(u)<r_{1}\right\}}-\left|Z_{n}\right|^{\alpha} \mathbb{1}_{\{n \leq T(u)\}} \mathbb{1}_{\left\{n \leq r_{1}\right\}}\right] \\
& =\lim _{n \rightarrow \infty} \mathbf{E}^{\alpha}\left[\lim _{u \rightarrow \infty}\left(\left|Z_{T(u)}\right|^{\alpha} \mathbb{1}_{\left\{T(u)<r_{1}\right\}}-\left|Z_{n}\right|^{\alpha} \mathbb{1}_{\{n \leq T(u)\}} \mathbb{1}_{\left\{n \leq r_{1}\right\}}\right)\right] \\
& =\lim _{n \rightarrow \infty} \mathbf{E}^{\alpha}\left[|Z|^{\alpha} \mathbb{1}_{\left\{r_{1}=\infty\right\}}-\left|Z_{n}\right|^{\alpha} \mathbb{1}_{\left\{n \leq r_{1}\right\}}\right]=0 .
\end{aligned}
$$

It remains to consider (II.1). Note that, given $\mathcal{F}_{n}, n \leq T(u)$, the random variable $\log \left|X_{T(u)}\right|-\log u$ converges in distribution to some positive random variable $\mathfrak{X}$-which is independent of $\mathcal{F}_{n}, n \leq T(u)$-as $u \rightarrow \infty$, under the $\alpha$-shifted measure (cf. e.g. Theorem 3.8 of [13]). Hence we have that

$$
\lim _{u \rightarrow \infty} \mathbf{E}^{\alpha}\left[\left.\left|\frac{X_{T(u)}}{u}\right|^{-\alpha} \right\rvert\, \mathcal{F}_{n}\right] \mathbb{1}_{\{n \leq T(u)\}}=\mathbf{E}\left[e^{-\alpha \mathfrak{X}}\right]
$$

Moreover, using dominated convergence and the fact $\mathbb{1}_{\{n \leq T(u)\}} \mathbf{E}^{\alpha}\left[\left|X_{T(u)} / u\right|^{-\alpha} \mid \mathcal{F}_{n}\right] \leq 1$, we obtain

$$
\begin{aligned}
\lim _{n \rightarrow \infty} \lim _{u \rightarrow \infty} \text { (II.1) } & =\lim _{n \rightarrow \infty} \mathbf{E}^{\alpha}\left[\left|Z_{n}\right|^{\alpha} \mathbb{1}_{\left\{n \leq r_{1}\right\}} \lim _{u \rightarrow \infty} \mathbf{E}^{\alpha}\left[\left.\left|\frac{X_{T(u)}}{u}\right|^{-\alpha} \right\rvert\, \mathcal{F}_{n}\right] \mathbb{1}_{\{n \leq T(u)\}}\right] \\
& =\mathbf{E}\left[e^{-\alpha \mathfrak{X}}\right] \lim _{n \rightarrow \infty} \mathbf{E}^{\alpha}\left[\left|Z_{n}\right|^{\alpha} \mathbb{1}_{\left\{n \leq r_{1}\right\}}\right]=\mathbf{E}\left[e^{-\alpha \mathfrak{X}}\right] \mathbf{E}^{\alpha}\left[|Z|^{\alpha} \mathbb{1}_{\left\{r_{1}=\infty\right\}}\right]
\end{aligned}
$$

completing the proof
Proof of Lemma 5.11. To begin with, we write, for some $\delta>0$,

$$
\begin{aligned}
\mathbf{P}\left(\left(\mathfrak{E}_{2}(u)\right)^{c} \mid X_{0}=v u^{\beta}\right) & =\mathbf{P}\left(\exists n<K_{\beta}^{\gamma}(u):\left|B_{n}\right|>u^{\gamma} \mid X_{0}=v u^{\beta}\right) \\
& \leq \mathbf{P}\left(\exists n<\tau_{d}:\left|B_{n}\right|>u^{\gamma} \mid X_{0}=v u^{\beta}\right) \\
& \leq \mathbf{P}\left(\exists n \leq u^{\delta}:\left|B_{n}\right|>u^{\gamma}\right)+\mathbf{P}\left(\tau_{d} \geq u^{\delta} \mid X_{0}=v u^{\beta}\right) \\
& =\mathbf{( I I I . 1 )}+\mathbf{( I I I . 2 )} .
\end{aligned}
$$

To bound (III.1), we have that

$$
\text { (III.1) } \leq u^{\delta} \mathbf{P}\left(\left|B_{1}\right|>u^{\gamma}\right) \leq u^{\delta-\alpha \gamma} \mathbf{E}\left|B_{1}\right|^{\alpha}=o\left(u^{-(1-\beta) \alpha}\right)
$$

for $(1-\beta) \alpha+\delta-\alpha \gamma<0$. Since (III.2) $\leq u^{-(\alpha+L) \delta} \mathbf{E}\left[\tau_{d}^{\alpha+L} \mid X_{0}=v u^{\beta}\right]$, it is sufficient to bound $\mathbf{E}\left[\tau_{d}^{\alpha+L} \mid X_{0}=v u^{\beta}\right]$. Recall $\left\{Y_{n}\right\}_{n \geq 0}$ is the $\mathbb{R}_{+}$-valued Markov chain defined by $Y_{n+1}=A_{n+1} Y_{n}+\left|B_{n+1}\right|$, for $n \geq 0$, and $\tau=\inf \left\{n \geq 1: Y_{n} \leq d\right\}$. Note that $\mathbf{E}\left[\tau_{d}^{\alpha+L} \mid X_{0}=\right.$ $\left.v u^{\beta}\right] \leq \mathbf{E}\left[\tau^{\alpha+L}\left|Y_{0}=|v| u^{\beta}\right]\right.$. Combining this with Lemma 5.5, we conclude that there exist $c$ and $u_{0}$ such that

$$
\text { (III.2) } \leq u^{-(\alpha+L) \delta} \mathbf{E}\left[\tau^{\alpha+L}\left|Y_{0}=|v| u^{\beta}\right] \leq c|v| u^{\beta} u^{-(\alpha+L) \delta}, \quad \forall u \geq u_{0}\right.
$$

Note that we can set $L=L(\delta, \alpha, \beta)$ to be arbitrarily large. Combining the estimates above for (III.1) and (III.2), we conclude the proof.

## 6 Proofs of Sections 3.2 and 3.3

Again, we briefly describe our proof strategy before diving into the technicalities. Define $\bar{X}_{n}^{\prime}=\left\{\bar{X}_{n}^{\prime}(t), t \in[0,1]\right\}$, where

$$
\begin{equation*}
\bar{X}_{n}^{\prime}(t)=\frac{1}{n} \sum_{i=1}^{N(n t)} X_{i}^{\prime} \quad \text { and } \quad X_{i}^{\prime}=\sum_{j=r_{i-1}}^{r_{i}-1} X_{j} \tag{6.1}
\end{equation*}
$$

where $\left\{r_{i}\right\}_{i \geq 0}$ is the sequence of regeneration times as in Remark 2.2, and

$$
\begin{equation*}
N(s)=\sup \left\{j \geq 0: r_{j}-1 \leq s\right\} \tag{6.2}
\end{equation*}
$$

Thanks to Theorem 4.1 of [35] and Theorem 3.1 above, we are able to establish an asymptotic equivalence between $\bar{X}_{n}^{\prime}$ and some random walk $\bar{W}_{n}$ that will be specified below. This allows us to provide a large deviations result for $\bar{X}_{n}^{\prime}$, using Lemma 2.13. In both the one-sided and the two-sided case, we will show that the residual process $\bar{X}_{n}-\bar{X}_{n}^{\prime}$ is negligible in an asymptotic sense.

We state here three lemmata that will play key roles in the proofs of Theorems 3.2 and 3.3. Let $\bar{W}_{n}=\left\{\bar{W}_{n}(t), t \in[0,1]\right\}$ be such that

$$
\begin{equation*}
\bar{W}_{n}(t)=\frac{1}{n} \sum_{i=1}^{\left\lfloor n t / \mathbf{E} r_{1}\right\rfloor} X_{i}^{\prime} \tag{6.3}
\end{equation*}
$$

where $X_{i}^{\prime}$ is as in (6.1). We begin with stating an asymptotic equivalence between $\bar{X}_{n}^{\prime}$ and $\bar{W}_{n}$, however, w.r.t. the $J_{1}$-topology, which is stronger than the $M_{1}^{\prime}$-topology introduced in the beginning of Section 3.2. Let $d_{J_{1}}$ denote the Skorokhod $J_{1}$ metric on $\mathbb{D}$, which is defined by

$$
d_{J_{1}}\left(\xi_{1}, \xi_{2}\right)=\inf _{\lambda \in \Lambda}\|\lambda-i d\|_{\infty} \vee\left\|\xi_{1} \circ \lambda-\xi_{2}\right\|_{\infty}, \quad \xi_{1}, \xi_{2} \in \mathbb{D}
$$

where $i d$ denotes the identity mapping, $\|\cdot\|_{\infty}$ denotes the uniform metric, that is, $\|x\|_{\infty}=\sup _{t \in[0,1]}|x(t)|$, and $\Lambda$ denotes the set of all strictly increasing, continuous bijections from $[0,1]$ to itself. Moreover, for $j \geq 0$, define

$$
\mathbb{D}_{\leqslant j}^{\mu}=\left\{\xi \in \underline{\mathbb{D}}_{\leqslant j}^{\mu}: \xi(0)=0\right\} \quad \text { and } \quad \mathbb{D}_{\ll j}^{\mu}=\left\{\xi \in \underline{D}_{\ll j}^{\mu}: \xi(0)=0\right\}
$$

Lemma 6.1. Consider the metric space ( $\mathbb{D}, d_{J_{1}}$ ). Suppose that Assumptions 2.1 and 2.4 hold. For any $j \geq 1$, the following holds.

1. If $B_{1} \geq 0$ and $C_{+}$as in Theorem 3.1 is strictly positive, then the stochastic process $\bar{X}_{n}^{\prime}$ is asymptotically equivalent to $\bar{W}_{n}$ w.r.t. $n^{-j(\alpha-1)}$ and $\mathbb{D}_{\leqslant j-1}^{\mu}$.
2. If $C_{+}$and $C_{-}$as in Theorem 3.1 satisfy $C_{+} C_{-}>0$, then the stochastic process $\bar{X}_{n}^{\prime}$ is asymptotically equivalent to $\bar{W}_{n}$ w.r.t. $n^{-j(\alpha-1)}$ and $\mathbb{D}_{\ll j}^{\mu}$.

Proof. We only show part 2), since part 1) can be proved by a similar argument. By Lemma 2.13, it is sufficient to show, for any $\delta>0$ and $\gamma>0$,

$$
\begin{align*}
& \limsup _{n \rightarrow \infty} n^{j(\alpha-1)} \mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \mathbb{D}_{\ll j}^{\mu}\right)^{-\gamma}, d_{J_{1}}\left(\bar{X}_{n}^{\prime}, \bar{W}_{n}\right) \geq \delta\right) \\
& =\limsup _{n \rightarrow \infty} n^{j(\alpha-1)} \mathbf{P}\left(\bar{W}_{n} \in\left(\mathbb{D} \backslash \mathbb{D}_{\ll j}^{\mu}\right)^{-\gamma}, d_{J_{1}}\left(\bar{X}_{n}^{\prime}, \bar{W}_{n}\right) \geq \delta\right)=0 . \tag{6.4}
\end{align*}
$$

To prove (6.4), it is convenient to consider the space of paths on a longer time horizon $[0,2]$. Let $\bar{W}_{n}$ denote the stochastic process $\left\{\bar{W}_{n}(t), t \in[0,2]\right\}$ over the time horizon $[0,2]$, and $\mathbb{D}_{\ll j}^{\mu ;[0,2]}$ denote the space of step functions on $[0,2]$ that corresponds to

$\mathbb{D}_{\ll j}^{\mu}$. Let $d_{J_{1}}^{[0,2]}$ denote the Skorokhod $J_{1}$ metric on $\mathbb{D}^{[0,2]}=\mathbb{D}([0,2], \mathbb{R})$. Note that $d_{J_{1}}\left(\bar{W}_{n}, \mathbb{D}_{\ll j}^{\mu}\right) \geq \gamma$ implies that $d_{J_{1}}^{[0,2]}\left(\bar{W}_{n}^{[0,2]}, \mathbb{D}_{\ll j}^{\mu ;[0,2]}\right) \geq \gamma$, and $d_{J_{1}}\left(\bar{X}_{n}^{\prime}, \mathbb{D}_{\ll j}^{\mu}\right) \geq \gamma$ implies that either $d_{J_{1}}^{[0,2]}\left(\bar{W}_{n}^{[0,2]}, \mathbb{D}_{\ll j}^{\mu ;[0,2]}\right) \geq \gamma$ or $2 n / \mathbf{E} r_{1} \leq N(n)$. Therefore, (6.4) is implied by

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} n^{j(\alpha-1)} \mathbf{P}\left(d_{J_{1}}^{[0,2]}\left(\bar{W}_{n}^{[0,2]}, \mathbb{D}_{\ll j}^{\mu ;[0,2]}\right) \geq \gamma, d_{J_{1}}\left(\bar{X}_{n}^{\prime}, \bar{W}_{n}\right) \geq \delta\right)=0 \tag{6.5}
\end{equation*}
$$

To prove (6.5), we adopt the construction of a piecewise linear nondecreasing homeomorphism $\bar{\lambda}_{n}$ from [35, the proof of Theorem 4.1]. Let $t_{0}=0$ and $t_{i}$ be the $i$-th jump time of $N(n \cdot)$ and $t_{L}$ be the last jump time of $N(n \cdot)$. Let $L=\left(\left\lfloor n / \mathbf{E} r_{1}\right\rfloor-1\right) \wedge N(n)$. Define $\bar{\lambda}_{n}$ in such a way that $\bar{\lambda}_{n}(t)=\mathbf{E} r_{1} N(n t) / n$ on $t_{0}, \ldots, t_{L}, \bar{\lambda}_{n}(1)=1$, and $\bar{\lambda}_{n}$ is a piecewise linear interpolation in between. For such $\bar{\lambda}_{n}, \bar{W}_{n}\left(\bar{\lambda}_{n}(t)\right)=\bar{X}_{n}^{\prime}(t)$ for all $t \in\left[0, t_{L}\right]$, and hence, $\left\|\bar{W}_{n} \circ \bar{\lambda}_{n}-\bar{X}_{n}^{\prime}\right\|_{\infty}=\sup _{t \in\left[t_{L}, 1\right]}\left|\bar{W}_{n} \circ \bar{\lambda}_{n}(t)-\bar{X}_{n}^{\prime}(t)\right|$. Therefore,

$$
\begin{align*}
d_{J_{1}}\left(\bar{W}_{n}, \bar{X}_{n}^{\prime}\right) & =\inf _{\lambda \in \Lambda}\|\lambda-i d\|_{\infty} \vee\left\|\bar{W}_{n} \circ \lambda-\bar{X}_{n}^{\prime}\right\|_{\infty} \leq\left\|\bar{\lambda}_{n}-i d\right\|_{\infty} \vee\left\|\bar{W}_{n} \circ \bar{\lambda}_{n}-\bar{X}_{n}^{\prime}\right\|_{\infty} \\
& =\left\|\bar{\lambda}_{n}-i d\right\|_{\infty} \vee \sup _{t \in\left[t_{L}, 1\right]}\left|\bar{W}_{n} \circ \bar{\lambda}_{n}(t)-\bar{X}_{n}^{\prime}(t)\right| \tag{6.6}
\end{align*}
$$

The second term can be bounded (with high probability) as follows. For an arbitrary $\epsilon>0$, consider two cases: $\left\lfloor n / \mathbf{E} r_{1}-n \epsilon\right\rfloor<N(n)<\left\lfloor n / \mathbf{E} r_{1}\right\rfloor$ and $\left\lfloor n / \mathbf{E} r_{1}\right\rfloor \leq N(n) \leq\left\lfloor n / \mathbf{E} r_{1}+n \epsilon\right\rfloor$. Set

W_{n}=\sum_{i=1}^{\left\lfloor n / \mathbf{E} r_{1}\right\rfloor} X_{i}^{\prime}
$$

If $\left\lfloor n / \mathbf{E} r_{1}-n \epsilon\right\rfloor<N(n)<\left\lfloor n / \mathbf{E} r_{1}\right\rfloor$, by the construction of $\bar{\lambda}_{n}$,

$$
\begin{equation*}
\sup _{t \in\left[t_{L}, 1\right]}\left|\bar{W}_{n} \circ \bar{\lambda}_{n}(t)-\bar{X}_{n}^{\prime}(t)\right| \leq \sup _{s, t \in[1-\epsilon, 1]}\left|\bar{W}_{n}(s)-\bar{W}_{n}(t)\right| . \tag{6.7}
\end{equation*}
$$

On the other hand, if $\left\lfloor n / \mathbf{E} r_{1}\right\rfloor \leq N(n) \leq\left\lfloor n / \mathbf{E} r_{1}+n \epsilon\right\rfloor$,

$$
\begin{equation*}
\sup _{t \in\left[t_{L}, 1\right]}\left|\bar{W}_{n} \circ \bar{\lambda}_{n}(t)-\bar{X}_{n}^{\prime}(t)\right| \leq \sup _{s, t \in[1,1+\epsilon]}\left|\bar{W}_{n}(s)-\bar{W}_{n}(t)\right| . \tag{6.8}
\end{equation*}
$$

From (6.7) and (6.8), we see that on the event $\left\{\left\lfloor n / \mathbf{E} r_{1}-n \epsilon\right\rfloor<N(n) \leq\left\lfloor n / \mathbf{E} r_{1}+n \epsilon\right\rfloor\right\}$,

$$
\begin{equation*}
\sup _{t \in\left[t_{L}, 1\right]}\left|\bar{W}_{n} \circ \bar{\lambda}_{n}(t)-\bar{X}_{n}^{\prime}(t)\right| \leq \sup _{s, t \in[1-\epsilon, 1+\epsilon]}\left|\bar{W}_{n}(s)-\bar{W}_{n}(t)\right| . \tag{6.9}
\end{equation*}
$$

Using (6.6) and (6.9), we obtain that

$$
\begin{align*}
& \mathbf{P}\left(d_{J_{1}}^{[0,2]}\left(\bar{W}_{n}^{[0,2]}, \mathbb{D}_{\ll j}^{\mu ;[0,2]}\right) \geq \gamma, d_{J_{1}}\left(\bar{X}_{n}^{\prime}, \bar{W}_{n}\right) \geq \delta\right) \\
& \leq \\
& \quad \mathbf{P}\left(d_{J_{1}}^{[0,2]}\left(\bar{W}_{n}^{[0,2]}, \mathbb{D}_{\ll j}^{\mu ;[0,2]}\right) \geq \gamma, \sup _{s, t \in[1-\epsilon, 1+\epsilon]}\left|\bar{W}_{n}(s)-\bar{W}_{n}(t)\right| \geq \delta\right)  \tag{6.10}\\
& \quad+\mathbf{P}\left(\left\{\left\lfloor n / \mathbf{E} r_{1}-n \epsilon\right\rfloor<N(n) \leq\left\lfloor n / \mathbf{E} r_{1}+n \epsilon\right]\right\}^{c}\right)+\mathbf{P}\left(\left\|\bar{\lambda}_{n}-i d\right\|_{\infty} \geq \delta\right) .
\end{align*}
$$

Thanks to Cramér's theorem, the second term in (6.10) decays geometrically. Moreover, using that $\bar{\lambda}_{n}(t)=\mathbf{E} r_{1} N(n t) / n$ on $t_{0}, \ldots, t_{L}$ (and linearly interpolated in between), we can write the last term in (6.10) as $\mathbf{P}\left(\left\|N(n \cdot) / n-\cdot / \mathbf{E} r_{1}\right\|_{\infty}>\delta\right.$ ), which converges to 0 in view of the functional law of large numbers for renewal processes (see e.g. Theorem 5.10 of [11]).

For the first term in (6.10), we have that (see [35, page 21])

$$
\limsup _{n \rightarrow \infty} n^{j(\alpha-1)} \mathbf{P}\left(d_{J_{1}}^{[0,2]}\left(\bar{W}_{n}^{[0,2]}, \mathbb{D}_{\ll j}^{\mu ;[0,2]}\right) \geq \gamma, \sup _{s, t \in[1-\epsilon, 1+\epsilon]}\left|\bar{W}_{n}(s)-\bar{W}_{n}(t)\right| \geq \delta\right) \leq c \epsilon
$$

for some $c>0$, where the intuition behind the asymptotics above is that, given the rare event takes place, the random walk $\bar{W}_{n}^{[0,2]}$ must have $j$ big jumps and one of them has to occur in the time interval $[1-\epsilon, 1+\epsilon]$. Since the choice of $\epsilon>0$ was arbitrary, (6.4) is proved by letting $\epsilon \rightarrow 0$.

The next two lemmata are useful for future purposes.
Lemma 6.2. For $\xi, \zeta \in \mathbb{D}$, we have that $d_{M_{1}^{\prime}}(\xi, \zeta) \leq d_{J_{1}}(\xi, \zeta)$.
Proof. As explained in Section 2.1 of [36], $d_{M_{1}^{\prime}}(\xi, \zeta) \leq d_{M_{1}}(\xi, \zeta)$. Furthermore, by Theorem 12.3.2 of [37], $d_{M_{1}}(\xi, \zeta) \leq d_{J_{1}}(\xi, \zeta)$.

Recall that $\operatorname{Disc}(\xi)$ is the set of discontinuities of $\xi \in \mathbb{D}$ and was defined in (3.4).
Lemma 6.3. If $d_{M_{1}^{\prime}}\left(\xi_{n}, \xi\right) \rightarrow 0$ as $n \rightarrow \infty$, then, for each $t \in \operatorname{Disc}(\xi)^{c}$

$$
\lim _{\delta \downarrow 0} \limsup _{n \rightarrow \infty} \sup _{t_{1} \in \mathscr{B}_{\delta}(t) \cap[0,1]}\left|\xi_{n}\left(t_{1}\right)-\xi\left(t_{1}\right)\right|=0 .
$$

Proof. Let $t \in \operatorname{Disc}(\xi)^{c}$. We first prove the statement for the case where $t \in(0,1)$. Let $\epsilon>0$ be fixed. Choose $\delta=\delta(\epsilon)>0$ such that

\begin{equation*}
\left|\xi\left(t_{1}\right)-\xi(t)\right|<\epsilon, \quad \text { for } t_{1} \in \mathscr{B}_{\delta}(t) \subseteq(0,1) \tag{6.11}
\end{equation*}
$$

By the definition of $M_{1}^{\prime}$ convergence, for given $\epsilon$, there exists $n_{0}$, such that $d_{M_{1}^{\prime}}\left(\xi_{n}, \xi\right)<$ $(\delta \wedge \epsilon) / 8$ for all $n \geq n_{0}$. Moreover, for each fixed $n \geq n_{0}$, one can find $\left(u_{n}, v_{n}\right) \in \Gamma^{\prime}\left(\xi_{n}\right)$ and $(u, v) \in \Gamma^{\prime}(\xi)$ such that

$$
\begin{equation*}
\left\|u_{n}-u\right\|_{\infty} \vee\left\|v_{n}-v\right\|_{\infty}<(\delta \wedge \epsilon) / 4 \tag{6.12}
\end{equation*}
$$

Let $\underline{s}, s, \bar{s}$ be such that $v(\underline{s})=t-\delta / 2, v(s)=t$ and $v(\bar{s})=t+\delta / 2$. Moreover, by (6.12) we have that $v_{n}(\underline{s})<t-\delta / 4$ and $v_{n}(\bar{s})>t+\delta / 4$. Thus, for all $t_{1} \in(t-\delta / 4, t+\delta / 4)$ there exists $s_{n} \in(\underline{s}, \bar{s})$ such that $\left(u_{n}\left(s_{n}\right), v_{n}\left(s_{n}\right)\right)=\left(\xi_{n}\left(t_{1}\right), t_{1}\right)$. Combining this with (6.11) and (6.12), we obtain that

\begin{aligned}
\left|\xi_{n}\left(t_{1}\right)-\xi\left(t_{1}\right)\right| & \leq\left|\xi_{n}\left(t_{1}\right)-\xi(t)\right|+\left|\xi\left(t_{1}\right)-\xi(t)\right|=\left|u_{n}\left(s_{n}\right)-u(s)\right|+\left|\xi\left(t_{1}\right)-\xi(t)\right| \\
& \leq\left|u_{n}\left(s_{n}\right)-u\left(s_{n}\right)\right|+\left|u\left(s_{n}\right)-u(s)\right|+\epsilon \\
& \leq(\delta \wedge \epsilon) / 2+\epsilon+\epsilon<3 \epsilon .
\end{aligned}
$$

Finally, the case where $t \in\{0,1\}$ can be dealt with similarly.
The remainder of this section is split into two parts that deal with Theorems 3.2 and 3.3.

### 6.1 Proof of Theorem 3.2

We consider the case where $B_{1}$ is nonnegative. Let us give the "roadmap" of proving Theorem 3.2.

- In Corollary 6.5 below we establish a sample-path large deviations result for the aggregated process $\bar{X}_{n}^{\prime}$ (see (6.1) above) by considering a suitably defined random walk together with utilizing Theorem 4.1 of [35]. For the IM-convergence in Corollary 6.5 we need Lemma 6.4 below.
- In Proposition 6.6 we show the asymptotic equivalence between the aggregated process $\bar{X}_{n}^{\prime}$ and the original process $\bar{X}_{n}$. Again, one technical lemma, see Lemma 6.7 below, is needed.
- Part 1) of Theorem 3.2 follows by combining Corollary 6.5 with Proposition 6.6. Part 2) is a direct consequence of part 1).
Lemma 6.4. For all $j \geq 0$ and all $z \in \mathbb{R}$, the set $\underline{\mathbb{D}}_{\leqslant j}^{z}$ is closed w.r.t. ( $\mathbb{D}, d_{M_{1}^{\prime}}$ ).
Recall that $C_{j}^{z}$ was defined in (3.6) for $z \in \mathbb{R}$.
Corollary 6.5. Suppose that Assumptions 2.1 and 2.4 hold. Moreover, let $B_{1} \geq 0$ and $C_{+}$as in Theorem 3.1 be strictly positive. For any $j \geq 0$,

$$
n^{j(\alpha-1)} \mathbf{P}\left(\bar{X}_{n}^{\prime} \in \cdot\right) \rightarrow\left(C_{+} \mathbf{E} r_{1}\right)^{j} C_{j}^{\mu}(\cdot),
$$

in $\operatorname{MM}\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)$ as $n \rightarrow \infty$.
Proposition 6.6. Suppose that Assumptions 2.1 and 2.4 hold. If $B_{1} \geq 0$ and $C_{+}$as in Theorem 3.1 is strictly positive, then $\bar{X}_{n}$ is asymptotically equivalent to $\bar{X}_{n}^{\prime}$ w.r.t. $\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}$ and $\underline{\mathbb{D}}_{\leqslant j-1}^{\mu}$.
Proof of Theorem 3.2. Part 1) follows by combining Corollary 6.5 with Proposition 6.6. Part 2) is a direct consequence of part 1).

Proof of Lemma 6.4. We give the proof for the case where $z=0$, while the proof for $z \neq 0$ follows using similar arguments. The statement is trivial for $\underline{\mathbb{D}}_{\leqslant 0}=\{0\}$; we focus on the case where $j \geq 1$. Let $\xi_{n}, n \geq 1$, be a sequence such that $\xi_{n} \in \underline{D}_{\leqslant j}$, for all $n \geq 1$, and $\lim _{n \rightarrow \infty} d_{M_{1}^{\prime}}\left(\xi_{n}, \xi\right)=0$ for some $\xi \in \mathbb{D}$. Our goal is to prove that $\xi \in \underline{D}_{\leqslant j}$. Note that by Lemma 6.3 above, for every $t \in \operatorname{Disc}(\xi)^{c} \cup\{1\}$,

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \xi_{n}(t)=\xi(t) \tag{6.13}
\end{equation*}
$$

We first show that $\xi$ has at most $j$ discontinuity points. Assume that $|\operatorname{Disc}(\xi)| \geq j+1$. Then there exists $0 \leq t_{1,-}<t_{1,+}<\cdots<t_{j+1,-}<t_{j+1,+} \leq 1$ such that $t_{i,-}, t_{i,+} \in \operatorname{Disc}(\xi)^{c} \cup\{1\}$, and $\left|\xi\left(t_{i,-}\right)-\xi\left(t_{i,+}\right)\right|>0$, for all $i \in\{1, \ldots, j+1\}$. By (6.13), there exists $N^{\prime}$ such that $\left|\xi_{N^{\prime}}\left(t_{i,-}\right)-\xi_{N^{\prime}}\left(t_{i,+}\right)\right|>0$ for all $i \in\{1, \ldots, j+1\}$. This leads to the contradiction that $\left|\operatorname{Disc}\left(\xi_{N^{\prime}}\right)\right| \leq j$. Now let $\underline{t}<\bar{t}$ be two neighbouring discontinuity points of $\xi$. We claim that $\xi$ is constant on $(\underline{t}, \bar{t})$. To see this, assume that the opposite statement holds. Then there exists $t_{1}<t_{j+2}$ such that $\underline{t}<t_{1}<t_{j+2}<\bar{t}$ and $\xi\left(t_{1}\right) \neq \xi\left(t_{j+2}\right)$. W.l.o.g. we assume that $\xi\left(t_{1}\right)<\xi\left(t_{j+2}\right)$. Since $\xi$ is continuous on $(\underline{t}, \bar{t})$, there exists $t_{1}<t_{2}<\cdots<t_{j+2}$ such that

$$
\begin{equation*}
\xi\left(t_{1}\right)<\xi\left(t_{2}\right)<\cdots<\xi\left(t_{j+2}\right) \quad \text { with } \quad \epsilon^{\prime}=\min _{i \in\{1, \ldots, j+1\}} \xi\left(t_{i+1}\right)-\xi\left(t_{i}\right) . \tag{6.14}
\end{equation*}
$$

On the other hand, for any $\epsilon>0$, by (6.13) there exists $N=N(\epsilon)$ such that

$$
\begin{equation*}
\xi_{N}\left(t_{i}\right) \in\left(\xi\left(t_{i}\right)-\epsilon, \xi\left(t_{i}\right)+\epsilon\right), \quad \text { for all } i \in\{1, \ldots, j+2\} \tag{6.15}
\end{equation*}
$$

In view of (6.14) and (6.15), by choosing $\epsilon<\epsilon^{\prime}$ we conclude that $\xi_{N}$ has at least $j+1$ discontinuity points, which leads to the contradiction that $\left|\operatorname{Disc}\left(\xi_{N}\right)\right| \leq j$. Thus we conclude that $\xi$ is constant between any two neighbouring discontinuity points. Similarly one can show that $\xi\left(t^{+}\right)-\xi\left(t^{-}\right)>0$ for every $t \in \operatorname{Disc}(\xi)$.

Proof of Corollary 6.5. Note that $\underline{\mathbb{D}}_{\leqslant j}^{\mu}=\mathbb{D}_{\leqslant j}^{\mu} \cup\left\{\xi \in \mathbb{D}: \xi(0)>0, \xi-\xi(0) \in \mathbb{D}_{\leqslant j-1}^{\mu}\right\}$. In particular, $\mathbb{D}_{\leqslant j}^{\mu} \subseteq \underline{\mathbb{D}}_{\leqslant j}^{\mu}$. Using Lemma 6.2, Corollary 6.5 is a consequence of Lemma 6.1 and Theorem 4.1 in [35].

The following lemma is essential in the proof of Proposition 6.6. Recall $\bar{X}_{n}^{\prime}$ was defined in (6.1). Define

\begin{equation*}
R_{n}=\left\{R_{n}(t), t \in[0,1]\right\}, \quad \text { where } R_{n}(t)=\frac{1}{n} \sum_{i=r_{N(n)}}^{\lfloor n t\rfloor-1} X_{i} \tag{6.16}
\end{equation*}
$$

Lemma 6.7. Suppose that Assumptions 2.1 and 2.4 hold. Moreover, let $B_{1} \geq 0$ and $C_{+}$ as in Theorem 3.1 be strictly positive. The following holds for any $\delta>0, \gamma>0$, and $j \geq 0$.

1. First we have that

$$
\mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma}, R_{n}(1) \geq \delta\right)=o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j+1}\right), \quad \text { as } n \rightarrow \infty .
$$

2. Moreover, we have that

$$
\mathbf{P}\left(R_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant 1}\right)^{-\gamma}\right)=o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right), \quad \text { as } n \rightarrow \infty .
$$

Proof of Proposition 6.6. To begin with, for $\epsilon>0$, define

$$
\begin{equation*}
\mathfrak{E}_{3}^{\epsilon}(n)=\left\{N_{\epsilon}^{-}(n)<N(n) \leq N_{\epsilon}^{+}(n)\right\}, \tag{6.17}
\end{equation*}
$$

where $N_{\epsilon}^{-}(n)=\left\lfloor n / \mathbf{E} r_{1}-n \epsilon\right\rfloor$ and $N_{\epsilon}^{+}(n)=\left\lfloor n / \mathbf{E} r_{1}+n \epsilon\right\rfloor$. Using Cramér's theorem, it is easy to see that $\mathbf{P}\left(\mathfrak{E}_{3}^{\epsilon}(n)^{c}\right)$ decays exponentially to 0 as $n \rightarrow \infty$. Defining $\Delta_{i}=r_{i}-r_{i-1}$, we have that

\begin{equation*}
\left\{d_{M_{1}^{\prime}}\left(\bar{X}_{n}, \bar{X}_{n}^{\prime}\right) \geq 2 \delta\right\} \subseteq\left\{\exists i \leq N(n) \text { s.t. } \Delta_{i} \geq n \delta\right\} \cup\left\{R_{n}(1) \geq \delta\right\} . \tag{6.18}
\end{equation*}
$$

First we show that for any $j \geq 0, \delta>0$, and $\gamma>0$,

$$
\lim _{n \rightarrow \infty}\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{-j} \mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}, \bar{X}_{n}^{\prime}\right) \geq 2 \delta\right)=0
$$

By (6.18) we have that

$$
\begin{align*}
& \mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \underline{D}_{\leqslant j-1}^{\mu}\right)^{-\gamma}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}, \bar{X}_{n}^{\prime}\right) \geq 2 \delta\right) \\
& \leq \mathbf{P}\left(\exists i \leq N(n) \text { s.t. } \Delta_{i} \geq n \delta\right)+\mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma}, R_{n}(1) \geq \delta\right) \\
& =\mathbf{P}\left(\exists i \leq N(n) \text { s.t. } \Delta_{i} \geq n \delta\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right), \tag{6.19}
\end{align*}
$$

where in (6.19) we used Lemma 6.7 (1) above. It remains to analyze the first term in (6.19). Note that

& =\mathbf{P}\left(\exists i \leq N(n) \text { s.t. } \Delta_{i} \geq n \delta, \mathfrak{E}_{3}^{\epsilon}(n)\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right) \\
& \leq \mathbf{P}\left(\exists i \leq\left\lfloor n / \mathbf{E} \tau_{1}+n \epsilon\right\rfloor \text { s.t. } \Delta_{i} \geq n \delta\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right) \\
& \leq\left\lfloor n / \mathbf{E} r_{1}+n \epsilon\right\rfloor \mathbf{P}\left(r_{1} \geq n \delta\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right) \\
& =o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right),

& =\mathbf{P}\left(\bar{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in\left(\underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)_{\rho} \cap\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-2}^{\mu}\right)^{-\rho}, R_{n}(1) \geq \delta\right) \\
& \quad+\mathbf{P}\left(\bar{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in\left(\underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)_{\rho} \cap\left(\underline{\mathbb{D}}_{\leqslant j-2}^{\mu}\right)_{\rho}, R_{n}(1) \geq \delta\right)

& +\mathbf{P}\left(\bar{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in\left(\underline{\mathbb{D}}_{\leqslant j-2}^{\mu}\right)_{\rho}\right) \\

& \leq \mathbf{P}\left(X_{1}^{\prime} \geq n \delta\right) \sum_{k=N_{\epsilon}^{-}(n)}^{N_{\epsilon}^{+}(n)} \mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma / 2}\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j+1}\right) \\
& \leq 2 \epsilon n \mathbf{P}\left(X_{1}^{\prime} \geq n \delta\right) \mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\leqslant j-1}^{\mu}\right)^{-\gamma / 2}\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j+1}\right) \tag{6.20}
\end{align*}

It remains to consider the first term in (6.20). Using Corollary 6.5, we have that

& \leq \mathbf{P}\left(\sum_{i=1}^{N_{\epsilon}^{-}(n)} \Delta_{i} \leq n \rho\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right) \\
& \leq \mathbf{P}\left(\sum_{i=1}^{N_{\epsilon}^{-}(n)} \frac{\Delta_{i}}{N_{\epsilon}^{-}(n)} \leq \frac{\rho}{1 / \mathbf{E} r_{1}-\epsilon}\right)+o\left(\left(n \mathbf{P}\left(X_{1}^{\prime} \geq n\right)\right)^{j}\right) . \tag{6.22}

Note that, for every $\rho \in(0,1)$ there exists a sufficiently small $\epsilon>0$ such that $\rho /\left(1 / \mathbf{E} r_{1}-\right.$ $\epsilon)<\mathbf{E} r_{1}$. For this choice of $\epsilon$, the first term in (6.22) decays exponentially thanks to Cramér's theorem.

### 6.2 Proof of Theorem 3.3

We consider the case where $B_{1}$ is a general random variable taking values in $\mathbb{R}$. The idea behind the proof of Theorem 3.3 is similar to the one in the one-sided case:

- In Corollary 6.9 below we establish a sample-path large deviations result for the aggregated process $\bar{X}_{n}^{\prime}$ (see (6.1) above).
- In Proposition 6.10 we show the asymptotic equivalence between the aggregated process $\bar{X}_{n}^{\prime}$ and the original process $\bar{X}_{n}$. In Lemma 6.11 we deal with the technical issues appearing in Proposition 6.10.
- Part 1) of Theorem 3.3 follows by combining Corollary 6.9 with Proposition 6.10. Part 2) is a direct consequence of part 1).

Lemma 6.8. For all $j \geq 0$ and all $z \in \mathbb{R}$, the set $\underline{\mathbb{D}}_{\ll j}^{z}$ is closed w.r.t. $\left(\mathbb{D}, d_{M_{1}^{\prime}}\right)$.
The proof of Lemma 6.8 is similar to the proof of Lemma 6.4 and therefore omitted. Recall $C_{j, k}^{z}$ was defined in (3.9). Let $C_{+}, C_{-}$be as in Theorem 3.1.

3. For any $i \in\left\{N_{\epsilon}^{-}(n), \ldots, N_{\epsilon}^{+}(n)\right\}, j \geq 1, \delta>0$, and $\epsilon>0$, there exists $c$ and $n_{0}$ (independent of $i$ ) such that

It is easy to check that indeed $\left(\bar{u}_{2}^{i}, \bar{v}_{2}^{i}\right)$ is a parametric representation of $\Gamma^{\prime}\left(\bar{X}_{i, n}^{\prime}\right)$. Moreover, $\left\|u_{1}^{i}-\bar{u}_{2}^{i}\right\|_{\infty}=\left\|u_{1}^{i}-u_{2}^{i}\right\|_{\infty}<\delta+\eta$,

Finally, we define parametric representations $\left(u_{1}, v_{1}\right) \in \Gamma^{\prime}\left(\bar{X}_{n}\right)$ and $\left(u_{2}, v_{2}\right) \in \Gamma^{\prime}\left(\bar{X}_{n}^{\prime}\right)$ by $v_{i}(s)=v_{i}^{j}(s)$, and $u_{i}(s)=u_{i}^{j}(s)+\sum_{k=1}^{j-1} X_{k}^{\prime}$, for $s \in\left[s_{-}^{j}, s_{+}^{j}\right]$, $j \in\{1, \ldots, N(n)+1\}$, and $i \in\{1,2\}$. It is easy to check that $\left\|u_{1}-u_{2}\right\|_{\infty} \vee\left\|v_{1}-v_{2}\right\|_{\infty}<\delta+\eta$, and hence, $d\left(\bar{X}_{n}, \bar{X}_{n}^{\prime}\right) \leq\left\|u_{1}-u_{2}\right\|_{\infty} \vee\left\|v_{1}-v_{2}\right\|_{\infty}<\delta+\eta$. & =\sum_{p=N_{\epsilon}^{-}(n)}^{N_{\epsilon}^{+}(n)} \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j-i}^{\mu}\right)^{-\rho}, R_{N(n), n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll i}\right)^{-\rho / 2}, N(n)=p\right)+o\left(n^{-j(\alpha-1)}\right)
\end{aligned}
$$

$$
\begin{aligned}
& =\sum_{p=N_{\epsilon}^{-}(n)}^{N_{\epsilon}^{+}(n)} \mathbf{P}\left(\bar{X}_{\leqslant p, n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j-i}^{\mu}\right)^{-\rho}, R_{p, n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll i}\right)^{-\rho / 2}, N(n)=p\right)+o\left(n^{-j(\alpha-1)}\right) \\
& \leq \sum_{p=N_{\epsilon}^{-}(n)}^{N_{\epsilon}^{+}(n)} \mathbf{P}\left(\bar{X}_{\leqslant p, n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j-i}^{\mu}\right)^{-\rho}\right) \mathbf{P}\left(R_{p, n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll i}\right)^{-\rho / 2}\right)+o\left(n^{-j(\alpha-1)}\right) \\
& \leq \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j-i}^{\mu}\right)^{-\rho / 2}\right) \sum_{p=N_{\epsilon}^{-}(n)}^{N_{\epsilon}^{+(n)}} \mathbf{P}\left(R_{p, n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll i}\right)^{-\rho / 2}\right)+o\left(n^{-j(\alpha-1)}\right) \\
& =\mathcal{O}\left(n^{-(j-i)(\alpha-1)}\right) 2 \epsilon \mathcal{O}\left(n^{-i(\alpha-1)}\right)+o\left(n^{-j(\alpha-1)}\right),
\end{aligned}
$$

where in the final step we use Lemma 6.11 (2)-(3). Letting $\epsilon \rightarrow 0$, we prove that the summation in (6.31) is of order $o\left(n^{-j(\alpha-1)}\right)$. Proof of Lemma 6.11. Let $\mathbb{D}^{s}$ denote the set of all step functions in $\mathbb{D}$. Let $\mathbb{D}^{s, \uparrow}$ denote the set of all nondecreasing step functions in $\mathbb{D}$. Define the mapping $\Psi^{\uparrow}: \mathbb{D}^{s} \rightarrow \mathbb{D}^{s, \uparrow}$ by $\zeta=\Psi^{\uparrow}(\xi)$ and

is a subset of $\left\{T_{2}\left(n^{\beta}\right)<r_{1}\right\}$. We distinguish between the cases 1) $\sup _{k \leq r_{i}} \frac{1}{n} \sum_{j=r_{i-1}}^{k-1} X_{j} \geq$ $\delta$, and 2) $\inf _{k \leq r_{i}} \frac{1}{n} \sum_{j=r_{i-1}}^{k-1} X_{j} \leq-\delta$. We focus on 1), since 2) can be dealt with by replacing $X_{i}$ by $-X_{i}$. Note that

In view of (i) and (ii), we have that

Using the fact that $\mathbf{P}\left(r_{1}>n \delta / 2\right)$ decays exponentially, we are able to restrict ourselves to the case where $r_{1} \leq n \delta / 2$. Let $\left(t_{0}, \ldots, t_{k}\right)$ be as in the r.h.s. of (6.35). Using the fact that, under the $M_{1}^{\prime}$ topology, jumps with the same sign "merge" into one jump in case they are "close", we conclude that $\operatorname{sign}\left(\xi\left(t_{i}\right)\right) \operatorname{sign}\left(\xi\left(t_{i-1}\right)\right)=-1$ for $i \in\{1, \ldots, k\}$. Now, it remains to show that $\mathbf{P}\left(T_{k}\left(u^{\beta}\right)<r_{1}\right)=\mathcal{O}\left(u^{-(k-\epsilon) \alpha}\right)$ as $u \rightarrow \infty$. We prove this by induction in $k$. & =\mathbf{E}^{\mathscr{D}}\left[\mathbb{1}_{\left\{T\left(u^{\beta}\right)<r_{1}\right\}} u^{(\beta-\gamma) \alpha} \mathbf{P}^{\mathscr{D}}\left(T_{2}\left(u^{\beta}\right)<K_{\beta}^{\gamma}(u) \mid \mathcal{F}_{T\left(u^{\beta}\right)}\right)\left|\frac{X_{T\left(u^{\beta}\right)}}{u^{\beta} Z_{T\left(u^{\beta}\right)}}\right|^{-\alpha}\right] . \tag{6.38}

& \leq \mathbf{P}^{\mathscr{D}}\left(\left|B_{n}\right| \leq u^{\gamma}, \forall T\left(u^{\beta}\right)<n<r_{1}, T_{2}\left(u^{\beta}\right)<K_{\beta}^{\gamma}(u) \mid X_{T\left(u^{\beta}\right)}=v u^{\beta}\right) \\
& \quad+\mathbf{P}^{\mathscr{D}}\left(\exists T\left(u^{\beta}\right)<n<r_{1} \text { s.t. }\left|B_{n}\right|>u^{\gamma} \mid X_{T\left(u^{\beta}\right)}=v u^{\beta}\right) \\
& =\mathbf{P}\left(\left(\mathfrak{E}_{2}(u)\right)^{c} \mid X_{0}=v u^{\beta}\right)=o\left(u^{-(\beta-\gamma) \alpha}\right) v, \tag{6.39}
\end{align*}
$$

where the tail estimate in (6.39) is obtained by following the arguments in the proof of Lemma 5.11 and taking advantage of the additional assumption that $\mathbf{E}\left|B_{1}\right|^{m}<\infty$ for every $m \in \mathbb{Z}_{+}$. Plugging (6.39) into (6.38) and using the dominated convergence theorem, we obtain that

& =\mathbf{P}\left(\exists 0<n_{1}<\cdots<n_{k}<r_{1} \text { s.t. }\left|B_{n_{i}}\right|>u^{\gamma}, \forall i \leq k \mid X_{0}=v u^{\beta}\right) \\
& =\mathbf{P}\left(\exists 0<n_{1}<\cdots<n_{k}<r_{1} \text { s.t. }\left|B_{n_{i}}\right|>u^{\gamma}, \forall i \leq k\right)=o\left(u^{-(k \beta-\gamma) \alpha}\right), \tag{6.42}
\end{align*}
$$

where the tail estimate in (6.42) is obtained by following the arguments in the proof of Lemma 5.11 and taking advantage of the additional assumption that $\mathbf{E}\left|B_{1}\right|^{m}<\infty$ for every $m \in \mathbb{Z}_{+}$. & \mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}^{\prime}, \hat{X}_{n}\right) \geq \delta\right) \\
& \leq \mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{\geqslant j}^{\bar{\gamma}}, \exists i \leq N(n) \text { s.t. } d_{M_{1}^{\prime}}\left(\bar{X}_{i, n}, \bar{X}_{i, n}^{\prime}\right) \geq \delta\right)+o\left(n^{-j(\alpha-1)}\right) \\
& =o\left(n^{-j(\alpha-1)}\right)
\end{aligned}
$$

where $\mathcal{D}_{\geqslant j}^{\bar{\gamma}}$ is defined as in (6.26). It remains to show that, for any $j \geq 1, \gamma>0$, and $\delta>0$, there exists some $\rho>0$ so that

$$
\mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in\left(\underline{\mathbb{D}}_{\ll j}^{\mu}\right)_{\rho}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}^{\prime}, \hat{X}_{n}\right) \geq \delta\right)=o\left(n^{-j(\alpha-1)}\right)
$$

as $n \rightarrow \infty$. Recall, for $\gamma>0$ and $j \geq 1, \mathcal{D}_{\geqslant j}^{\gamma}=\left\{\xi \in \mathbb{D}:\left|\operatorname{Disc}_{\gamma}(\xi)\right| \geq j\right\}$, where $\operatorname{Disc}_{\gamma}(\xi)=\left\{t \in \operatorname{Disc}(\xi):\left|\xi(t)-\xi\left(t^{-}\right)\right| \geq \gamma\right\}$. Defining $\mathcal{D}_{=j}^{\rho}=\left\{\xi \in \mathbb{D}:\left|\operatorname{Disc}_{\gamma}(\xi)\right|=j\right\}$ for $j \in \mathbb{Z}$ and $\rho>0$, we have

$$
\begin{align*}
& \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in\left(\underline{\mathbb{D}}_{\ll j}^{\mu}\right)_{\rho}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}^{\prime}, \hat{X}_{n}\right) \geq \delta\right) \\
& \leq \mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{\geqslant_{0}}^{\rho_{0}}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}^{\prime}, \hat{X}_{n}\right) \geq \delta\right)+\mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in\left(\mathcal{D}_{\geqslant_{0 j-1}}^{\rho_{0}}\right)^{c}\right) \\
& \leq \mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{\geqslant_{j-1}}^{\rho_{0}}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}^{\prime}, \hat{X}_{n}\right) \geq \delta\right)+\sum_{i=1}^{j-1} \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-i-1}^{\rho_{0}}\right) \\
& =\mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{\geqslant j-1}^{\rho_{0}}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}^{\prime}, \hat{X}_{n}\right) \geq \delta\right)+\sum_{i=1}^{j-1} \mathbf{P}\left(E_{j}(i)\right) . \tag{6.43}
\end{align*}
$$

Note that

$$
\begin{align*}
& \mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{\geqslant j-1}^{\rho_{0}}, d_{M_{1}^{\prime}}\left(\bar{X}_{n}^{\prime}, \hat{X}_{n}\right) \geq \delta\right) \\
& \leq \mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{\geqslant j-1}^{\rho_{0}}, \exists i \leq N(n) \text { s.t. } d_{M_{1}^{\prime}}\left(\bar{X}_{i, n}, \bar{X}_{i, n}^{\prime}\right) \geq \delta\right)+o\left(n^{-j(\alpha-1)}\right) \\
& =\mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{\geqslant}^{\rho_{0}} \geqslant j-1, \mathfrak{E}_{3}^{\epsilon}(n), \exists i \leq N(n) s . t . d_{M_{1}^{\prime}}\left(\bar{X}_{i, n}, \bar{X}_{i, n}^{\prime}\right) \geq \delta\right)+o\left(n^{-j(\alpha-1)}\right) \\
& \leq \mathbf{P}\left(\exists\left(i_{0}, \ldots, i_{j-2}\right) \in \mathcal{P}\left(\left\{1, \ldots, N_{\epsilon}^{+}(n)\right\}, j-1\right) \mathrm{s.t.}\right. \\
& \left.\quad d_{M_{1}^{\prime}}\left(\bar{X}_{i_{0}, n}, \bar{X}_{i_{0}, n}^{\prime}\right) \geq \delta,\left|X_{i_{p}}^{\prime}\right| \geq n \rho_{0}, \forall 1 \leq p \leq j-2\right) \\
& =\mathcal{O}\left(n^{j-1} n^{-(2-\epsilon) \alpha} n^{-(j-2) \alpha}\right)+o\left(n^{-j(\alpha-1)}\right)=o\left(n^{-j(\alpha-1)}\right), \tag{6.44}
\end{align*}
$$

where in (6.44) we use Lemma 6.11 (1) together with the fact that the blocks $\left\{X_{r_{i-1}}, \ldots, X_{r_{i}}\right\}, i \geq 1$, are mutually independent, and the final equivalence is obtained by setting $\epsilon<1 / \alpha$. In view of the above computation, it remains to analyze $\mathbf{P}\left(E_{j}(k)\right)$, $k \in\{1, \ldots, j-1\}$ as in (6.43).

Let $I^{*}=\left\{i \leq N(n): d_{M_{1}^{\prime}}\left(\bar{X}_{i, n}, \bar{X}_{i, n}^{\prime}\right) \geq \rho_{1}\right\}$. Note that

$$
\begin{aligned}
& \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}}\right) \\
& =\mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}},\left|I^{*}\right| \geq(k+2) \wedge(j-k-2)\right) \\
& \quad+\mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{D}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}}, 1 \leq\left|I^{*}\right|<(k+2) \wedge(j-k-2)\right) \\
& \quad+\mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}},\left|I^{*}\right|=0\right) \\
& = \\
& \quad(\mathbf{V} . \mathbf{1})+\mathbf{( V . 2 )}+\mathbf{( V . 3 )} .
\end{aligned}
$$

Suppose that $k \leq j / 2-2$, where the case $k>j / 2-2$ can be dealt with similarly. Note that

$$
\begin{aligned}
\mathbf{( V . 1 ) ~} \leq & \mathbf{P}\left(\bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}},\left|I^{*}\right| \geq k+2, \mathfrak{E}_{3}^{\epsilon}(n)\right)+o\left(n^{-j(\alpha-1)}\right) \\
\leq & \mathbf{P}\left(\exists\left(i_{1}, \ldots, i_{j-k-2}\right) \in \mathcal{P}\left(\left\{1, \ldots, N_{\epsilon}^{+}(n)\right\}, j-k-2\right)\right. \text { s.t. } \\
& d_{M_{1}^{\prime}}\left(\bar{X}_{i_{p}, n}, \bar{X}_{i_{p}, n}^{\prime}\right) \geq \rho, \forall 1 \leq p \leq k+2, \\
& \left.\left|X_{i_{q}}^{\prime}\right| \geq n \rho_{0}, \forall k+3 \leq q \leq j-k-2\right) \\
& +o\left(n^{-j(\alpha-1)}\right) \\
= & \mathcal{O}\left(n^{j-k-2} n^{-(k+2)(2-\epsilon) \alpha} n^{-(j-2 k-4) \alpha}\right)+o\left(n^{-j(\alpha-1)}\right) \\
= & \mathcal{O}\left(n^{-j(\alpha-1)} n^{-(k+2)+(k+2) \epsilon \alpha}\right)+o\left(n^{-j(\alpha-1)}\right)=o\left(n^{-j(\alpha-1)}\right),
\end{aligned}
$$

if $\epsilon<1 / \alpha$. Moreover, we have that (V.3) $=o\left(n^{-j(\alpha-1)}\right)$ for $\rho_{0}$ sufficiently small. Let $I^{\prime}=\left\{i \leq N(n): \bar{X}_{i, n}^{\prime} \geq \rho_{0}\right\}$. Turning to bounding (V.2) we have that

$$
\begin{aligned}
\text { (V.2) }= & \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}}, 1 \leq\left|I^{*}\right| \leq k+1\right) \\
= & \sum_{k_{1}=1}^{k+1} \sum_{k_{2}=0}^{k_{1}} \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}},\right. \\
& +o\left(I^{*}\left|=k_{1},\left|I^{\prime} \cap I^{*}\right|=k_{2}, \mathfrak{E}_{3}^{\epsilon}(n)\right)\right. \\
&
\end{aligned}
$$

Defining $J=\left\{\left(l_{1}^{\prime}, \ldots, l_{k_{1}}^{\prime}\right): \mathbf{1}^{T}\left(l_{1}^{\prime}, \ldots, l_{k_{1}}^{\prime}\right)<k+2+k_{2}\right\}$, it is now sufficient to consider

$$
\begin{aligned}
& \mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}},\left|I^{*}\right|=k_{1},\left|I^{\prime} \cap I^{*}\right|=k_{2}, \mathfrak{E}_{3}^{\epsilon}(n)\right) \\
& \leq \mathbf{P}\left(\exists\left(i_{1}, \ldots, i_{j-k-2-k_{2}+k_{1}}\right) \in \mathcal{P}\left(\left\{1, \ldots, N_{\epsilon}^{+}(n)\right\}, j-k-2-k_{2}+k_{1}\right)\right. \text { s.t. } \\
& \left(\bar{X}_{i_{1}, n}, \ldots, \bar{X}_{i_{k_{1}}, n}\right) \in\left(\bigcup_{\left(l_{1}, \ldots, l_{k_{1}}\right) \in J} \prod_{p=1}^{k_{1}} \underline{D}_{l_{i_{p}}}\right)^{-\rho_{2}}, \\
& \left.\left|X_{i_{q}}^{\prime}\right| \geq n \rho_{0}, \forall k_{1}+1 \leq q \leq j-k-2-k_{2}+k_{1}\right) \\
& +\mathbf{P}\left(\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}, \bar{X}_{n}^{\prime} \in \mathcal{D}_{=j-k-2}^{\rho_{0}},\left|I^{*}\right|=k_{1},\left|I^{\prime} \cap I^{*}\right|=k_{2}, \mathfrak{E}_{3}^{\epsilon}(n),\right. \\
& \quad \exists\left(i_{1}, \ldots, i_{j-k-2-k_{2}+k_{1}}\right) \in \mathcal{P}\left(\left\{1, \ldots, N_{\epsilon}^{+}(n)\right\}, j-k-2-k_{2}+k_{1}\right) \\
& \quad \text { s.t. }\left(\bar{X}_{i_{1}, n}, \ldots, \bar{X}_{i_{k_{1}}, n}\right) \in\left(\bigcup_{\left(l_{1}, \ldots, l_{k_{1}}\right) \in J}^{\left.\prod_{p=1}^{k_{1}} \underline{D}_{l_{i_{p}}}\right)_{\rho_{2}},}\right. \\
& \left.\left|X_{i_{q}}^{\prime}\right| \geq n \rho_{0}, \forall k_{1}+1 \leq q \leq j-k-2-k_{2}+k_{1}\right) \\
& =\text { (V.2.a) }+\mathbf{( V . 2 . b ) . ~}
\end{aligned}
$$

Since $0 \leq k_{2} \leq k_{1} \leq k+1$ we have that

$$
\begin{aligned}
\mathbf{( V . 2 . a )} & \leq \mathcal{O}\left(n^{j-1}\right) \mathcal{O}\left(n^{-\left(k+2+k_{2}-k_{1} \delta\right) \alpha}\right) \mathcal{O}\left(n^{-\left(j-k-2-k_{2}\right) \alpha}\right) \\
& =\mathcal{O}\left(n^{-j(\alpha-1)} n^{k_{1} \delta \alpha-1}\right)=o\left(n^{-j(\alpha-1)}\right)
\end{aligned}
$$

for $\delta<1 /((k+1) \alpha)$. It remains to show that (V.2.b) $=o\left(n^{-j(\alpha-1)}\right)$. To see this, for $\epsilon>0$ there exists

$$
\begin{equation*}
\left(\zeta_{1}, \ldots, \zeta_{k_{1}}\right) \in \bigcup_{\left(l_{1}, \ldots, l_{k_{1}}\right) \in J} \prod_{p=1}^{k_{1}} \underline{D}_{l_{i_{p}}} \tag{6.45}
\end{equation*}
$$

such that $d\left(\bar{X}_{i_{p}, n}, \zeta_{i_{p}}\right) \leq \rho_{2}+\epsilon$, for all $1 \leq p \leq k_{1}$. Hence, we have that

$$
\begin{equation*}
d\left(\hat{X}_{n}, \bar{X}_{n}^{\prime}-\sum_{i \in I^{\prime} \cap\left\{i_{1}, \ldots, i_{k_{1}}\right\}} \bar{X}_{i, n}^{\prime}+\sum_{p=1}^{k_{1}} \zeta_{i_{p}}\right) \leq \rho_{1} \vee\left(\rho_{2}+\epsilon\right) \tag{6.46}
\end{equation*}
$$

For any $c>0$, define $\Phi_{c}: \mathbb{D} \rightarrow \mathbb{D}$ by

$$
\begin{equation*}
\Phi_{c}(\xi)(t)=\sum_{s \in[0, t] \cap \operatorname{Disc}(\xi, c)}\left(\xi(s)-\xi\left(s^{-}\right)\right), \quad \text { for } t \in[0,1], \tag{6.47}
\end{equation*}
$$

where $\operatorname{Disc}(\xi, c)\left\{t \in \operatorname{Disc}(\xi): \xi(t)-\xi\left(t^{-}\right) \geq c\right\}$. Now we claim that

$$
\begin{equation*}
\left\|\bar{X}_{n}^{\prime}-\Phi_{\rho_{0}}\left(\bar{X}_{n}^{\prime}\right)-\mu \cdot \mathrm{id}\right\|_{\infty}>\rho_{3} . \tag{6.48}
\end{equation*}
$$

To see this, suppose $\left\|\Phi_{\rho_{0}}\left(\bar{X}_{n}^{\prime}\right)-\mu \cdot \mathrm{id}\right\|_{\infty} \leq \rho_{3}$. Hence,

$$
\begin{align*}
& d\left(\bar{X}_{n}^{\prime}-\sum_{i \in I^{\prime} \cap\left\{i_{1}, \ldots, i_{k_{1}}\right\}} \bar{X}_{i, n}^{\prime}+\sum_{p=1}^{k_{1}} \zeta_{i_{p}}, \mu \cdot \mathrm{id}+\sum_{p=1}^{k_{1}} \zeta_{i_{p}}+\sum_{i \in I^{\prime} \backslash\left\{i_{1}, \ldots, i_{k_{1}}\right\}} \bar{X}_{i, n}^{\prime}\right) \\
& \leq\left\|\bar{X}_{n}^{\prime}-\sum_{i \in I^{\prime}} \bar{X}_{i, n}^{\prime}-\mu \cdot \mathrm{id}\right\|_{\infty}=\left\|\bar{X}_{n}^{\prime}-\Phi_{\rho_{0}}\left(\bar{X}_{n}^{\prime}\right)-\mu \cdot \mathrm{id}\right\|_{\infty} \leq \rho_{3} . \tag{6.49}
\end{align*}
$$

In view of (6.46) and (6.49) we obtain that

$$
d\left(\hat{X}_{n}, \mu \cdot \mathrm{id}+\sum_{p=1}^{k_{1}} \zeta_{i_{p}}+\sum_{i \in I^{\prime} \backslash\left\{i_{1}, \ldots, i_{k_{1}}\right\}} \bar{X}_{i, n}^{\prime}\right) \leq \rho_{1} \vee\left(\rho_{2}+\epsilon\right)+\rho_{3},
$$

where

$$
\mu \cdot \mathrm{id}+\sum_{p=1}^{k_{1}} \zeta_{i_{p}}+\sum_{i \in I^{\prime} \backslash\left\{i_{1}, \ldots, i_{k_{1}}\right\}} \bar{X}_{i, n}^{\prime} \in \underline{\mathbb{D}}_{\ll j}^{\mu}
$$

due to (6.45). This leads to the contradiction of $\hat{X}_{n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}^{\mu}\right)^{-\gamma}$ by choosing $\rho_{1}, \rho_{2}$ and $\rho_{3}$ small enough. In view of (6.48) we have that

$$
\begin{aligned}
\text { (V.2.b) } & \leq \mathbf{P}\left(\bar{X}_{n}^{\prime} \in\left\{\xi \in \mathbb{D}: \xi(t)-\sup _{t \in[0,1]}\left|\Phi_{\rho_{0}}(\xi)(t)-\mu t\right|>\rho_{3}\right\}\right) \\
& =o\left(n^{-j(\alpha-1)}\right),
\end{aligned}
$$

by choosing $\rho_{0}$ and $\rho_{3}$ such that $\rho_{3} / \rho_{0} \notin \mathbb{Z}$ and $\left\lceil\rho_{3} / \rho_{0}\right\rceil>j$.
Part 3): Since

$$
\mathbf{P}\left(r_{i+1}-r_{i}>r_{i} \delta\right) \leq \mathbf{P}\left(r_{i+1}-r_{i}>\left(n-\epsilon^{\prime}\right) \delta\right)+\mathbf{P}\left(r_{i} \geq n-\epsilon^{\prime}\right)
$$

$\mathbf{P}\left(r_{i+1}-r_{i}>r_{i} \delta\right)$ decays exponentially, for $i \in\left\{N_{\epsilon}^{-}(n), \ldots, N_{\epsilon}^{+}(n)\right\}$. Combining this with (6.35), we are able to utilize the argument as in (6.36) and obtain that

$$
\mathbf{P}\left(R_{i, n} \in\left(\mathbb{D} \backslash \underline{\mathbb{D}}_{\ll j}\right)^{-\delta}\right)=\mathbf{P}\left(T_{j}\left(n^{\beta}\right)<r_{1}\right)+o\left(n^{-(j-\epsilon) \alpha}\right)
$$

for any $\beta \in(0,1)$. Since $\mathbf{P}\left(T_{j}\left(u^{\beta}\right)<r_{1}\right)=\mathcal{O}\left(u^{-(j-\epsilon) \alpha}\right)$ for a suitable choice of $\beta$, the proof is completed.
