An asymptotic formula for the period of a Volterra-Lotka system

## Abstract

The periodic solution of a Volterra-Lotka system is considered as a relaxation oscillation. With perturbation techniques four local expansions are constructed from the implicitly given solution. Integration over the four regions leads to an asymptotic formula for the period.

## 1. Introduction

The system of differential equations

$$\frac{dh}{dt}^* = h^* (a - \alpha p^*), \qquad (1a)$$

$$\frac{\mathrm{dp}^*}{\mathrm{dt}^*} = \mathrm{p}^* \; (-\mathrm{b} + \beta \mathrm{h}^*) \tag{1b}$$

will have a one parameter family of periodic solutions with the equilibrium  $(h^*,p^*)=(b/\beta,a/\alpha)$  as center point. Volterra [2] computed that for small disturbances of the equilibrium the period of such a solution is

$$T \stackrel{*}{\sim} \frac{2\pi}{\sqrt{ab}} . \tag{2}$$

We will construct an asymptotic formula for the period which holds for large disturbances. For that purpose we consider the periodic solution as a relaxation oscillation. The substitutions

$$h^* = \frac{b}{\beta}h, \qquad p^* = \frac{a}{\alpha}p,$$
 (3a)

$$t^* = \frac{t}{a}$$
,  $a = \varepsilon b$ , (3b)

transform the system (1) into

$$\frac{dh}{dt} = h(1-p), \tag{4a}$$

$$\varepsilon \frac{\mathrm{d}p}{\mathrm{d}t} = p(-1+h). \tag{4b}$$

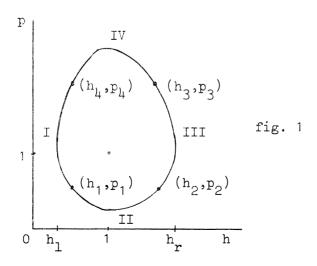
Let the initial values of (4) be

$$h(0) = h_1, \quad p(0) = 1$$
 (5)

where  $0 < h_1 < 1$ . In the (h,p)-plane (phase plane) we have the solution in an implicit form

$$h - log h + \epsilon (p - log p) + log h_1 - h_1 - \epsilon = 0.$$
 (6)

A system having a relaxation oscillation as solution contains a small parameter that multiplies one of the derivatives. In the following it is assumed that  $\epsilon$  is such a small, positive parameter.



## 2. Local asymptotic approximations

In figure 1 the periodic solution is given by a closed curve in the phase plane. This curve is divided into four segments separated by the points  $(h_i, p_i)$ , i = 1,2,3,4:

$$h_1 = h_1 (1 + \frac{1}{h_1 - 1} \epsilon \log \epsilon + \xi_1 \epsilon), p_1 = \eta_1 \epsilon,$$
 (7a)

$$h_2 = h_r \left(1 + \frac{1}{h_r - 1} \epsilon \log \epsilon + \xi_2 \epsilon\right), p_2 = \eta_2 \epsilon,$$
 (7b)

$$h_3 = h_r (1 - \xi_3),$$
  $p_3 = \eta_3 \epsilon^{-1},$  (7c)

$$h_{\mu} = h_{\gamma} (1 + \xi_{\mu}), p_{\mu} = \eta_{\mu} \epsilon^{-1}. (7d)$$

The constant  $h_r$  satisfies

$$h_r - \log h_r = h_1 - \log h_1 \tag{8}$$

such that  $h_1 < 1 < h_r$ . Since we have only one degree of freedom in choosing each of the points, there has to exist some relation between the positive constants  $\xi_i$  and  $\eta_i$ . In the four regions a convergent series expansion of the solution can be given in an explicit form. For the complete expansions the reader is referred to Veling [1], where the proof of the validity of the following asymptotic approximations is given.

I: 
$$h = h_1 + \frac{h_1}{1 - h_1} (p - \log p - 1)\epsilon + 0 \{(p - \log p - 1)^2 \epsilon^2\}, (9a)$$

II:  $p = \exp(\frac{h - \log h - h_1 + \log h_1 - \epsilon}{\epsilon}) + 0 [\exp(\frac{2(h - \log h - h_1 + \log h_1 - \epsilon)}{\epsilon})], (9b)$ 

III:  $h = h_r + \frac{h_r}{1 - h_r} (p - \log p - 1)\epsilon + 0 \{(p - \log p - 1)^2 \epsilon^2\}, (9c)$ 

IV:  $p = (\log h - h - \log h_1 + h_1 + \epsilon) \epsilon^{-1} - \log \epsilon + 0(1). (9d)$ 

For any  $\xi_1$  independent of  $\epsilon$  the expansions (9a) and (9b) are identical in  $(h_1,p_1)$  which can be verified by substituting one expansion into the other. This is also true for the other points. The constants  $\xi_3$  and  $\xi_4$  have upperbounds independent of  $\epsilon$  in order to have converging expansions.

## 3. The period

The period is composed of the following integrals

$$T = T_{I} + T_{II} + T_{III} + T_{IV}, \qquad (10)$$

$$T_{I} = \int_{p_{i_{1}}}^{p_{1}} \frac{dp}{(\frac{dp}{dt})}, \quad T_{II} = \int_{h_{1}}^{h_{2}} \frac{dh}{(\frac{dh}{dt})}, \quad T_{III} = \int_{h_{3}}^{h_{2}} \frac{dh}{(\frac{dh}{dt})}.$$

Using (4) and (9) we obtain

$$\begin{split} \mathbf{T}_{\mathrm{I}} &= \frac{2}{\mathrm{h_{1}}-1} \; \epsilon \; \log \; \epsilon \; + \; \{\xi_{1} \; - \; \frac{1 \; + \; \log(1-\mathrm{h_{1}}) \; + \; \log \; \xi_{1_{4}} \; + \\ & \; + \; f(\xi_{1_{4}})\} \epsilon \; + \; O(\epsilon^{2} \log^{2} \epsilon) \; , \\ \\ \mathbf{T}_{\mathrm{II}} &= (\log \; \mathrm{h_{1}} \; - \; \log \; \mathrm{h_{r}}) \; + \; (\frac{1}{\mathrm{h_{1}}-1} \; - \; \frac{1}{\mathrm{h_{r}}-1}) \; \epsilon \log \epsilon \; + \\ & \; + \; (\xi_{2}-\xi_{1}) \; \epsilon \; + \; O(\epsilon^{2} \; \log^{2} \epsilon) \; , \\ \\ \mathbf{T}_{\mathrm{III}} &= \frac{-2}{\mathrm{h_{r}}-1} \; \epsilon \log \epsilon \; + \; \{-\xi_{2} \; + \; \frac{1 \; + \; \log(\mathrm{h_{r}}-1) \; + \; \log \; \xi_{3}}{\mathrm{h_{r}}-1} \; + \\ & \; + \; g(\xi_{3})\} \epsilon \; + \; O(\epsilon^{2} \; \log^{2} \epsilon) \; , \end{split}$$

$$\begin{split} \mathbf{T}_{\text{IV}} &= \{\frac{-1}{h_1 - 1} \log \log \frac{1}{h_1} + \frac{1}{h_r - 1} \log \log h_r + \\ &+ \frac{1}{h_1 - 1} \log \xi_4 - \frac{1}{h_r - 1} \log \xi_3 - \mathbf{f}(\xi_4) - \mathbf{g}(\xi_3) + \\ &+ \mathbf{I}_1(h_1) + \mathbf{I}_r(h_r) \} \varepsilon + \mathbf{0}(\varepsilon^2 \log^2 \varepsilon), \end{split}$$

where the functions  $f(\xi_{\downarrow})$  and  $g(\xi_{3})$  are contributions from higher order terms of (9) which will cancel out. The terms  $I_{\downarrow}$  and  $I_{r}$  denote the integrals

$$I_{1}(h_{1}) = \int_{0}^{-\log h_{1}} \left\{ \frac{1}{x+h_{1}(1-e^{x})} - \frac{1}{(1-h_{1})x} \right\} dx,$$

$$I_{r}(h_{r}) = \int_{-\log h_{r}}^{0} \left\{ \frac{1}{x+h_{r}(1-e^{x})} - \frac{1}{(1-h_{r})x} \right\} dx.$$

$$T = (h_{r}-h_{1}) + (\frac{-1}{1-h_{1}} + \frac{1}{1-h_{r}}) \epsilon \log \epsilon + \left[ \frac{1}{1-h_{1}} - \frac{1}{1-h_{r}} + \frac{1}{1-h_{1}} \log \left\{ (1-h_{1}) \log \frac{1}{h_{1}} \right\} - \frac{1}{1-h_{r}} \log \left\{ (h_{r}-1) \log h_{r} \right\} + \frac{1}{1-h_{1}} (h_{1}) + I_{r}(h_{r}) \right] \epsilon + O(\epsilon^{2} \log^{2} \epsilon).$$

$$(11)$$

Notice that the artitrary constants  $\xi_{\, \underline{i}}$  and  $\eta_{\, \underline{i}}$  have canceled out.

In table I we compare the asymptotic formule (11) with the results obtained by numerical integration. Two different numerical methods were applied: a Runge-Kutta scheme (Rk4na, see Zonneveld [3]) for integrating system (4) and a method using the implicit formula (6). These numerical methods yield the same results in the required accuracy.
